- 1. Tender must be submitted in system generated data sheet format which is provided through e-procurement. The mentioned information should be clearly filled up in e-procurement and upload the same.
- 2. Only NSIC Single Point Registered firms for supplying above mentioned item may be exempted from submitting Tender Fee, EMD & Security Deposit against formal approach in techno-commercial bid alongwith a valid relevant NSIC Single Point Registration Certificate up to its monetary limit.
- 3. Following facilities / benefits will be given to MSEs:-
 - (a) Issue of Tender sets free of cost.
 - (b) Exemption for payment of Earnest Money Deposit.

Vendors registered with MSE (Micro & Small Enterprises) are eligible for the following benefits in accordance with the Public Procurement Policy for Micro & Small Enterprises, 2012.

- 8. No conditional offer and hard copy of offer will be accepted.

- 9. <u>TECHNICAL SPECIFICATION, SCOPE OF SUPPLY& SCOPE OF WORK:</u> As per SOTR attached -1 page.
- 10. Price shall be discovend through online bidding process to be conducted by the service provider. Quoted Price must be F.O.R. destination / GRSE basis. Price quoted should include for proper packing to withstand heavy / Sea / Air / Inland Transit and tropical storage during transit clearing & to be kept firm till execution of order in full.
- 11. **TAXES:** If Central Sales Tax as applicable will be paid extra at Concessional rate and STD form 'C' will be issued by GRSE.

In case of VAT: Percentage of VAT amount as applicable to be indicated.

- 12. **ACCEPTANCE:** It is not binding on the purchaser to accept the lowest or any tender. The purchaser reserves the right to accept any of the tender or part of a tender without assigning any reason. The purchaser reserves the right to split up the tender and place order for individual item with different suppliers. The purchaser also reserves the right to order 25% more / less of the total tendered quantity.
- 13. **SECRECY CLAUSE:** All information given to the supplier for the execution of the order is to be treated as SECRET / CONFIDENTIAL. The technical information, drawings, specification and other related documents forming part of this Enquiry / order are the property of Purchaser and shall not be used for any other purpose except for the execution of Order. Any information / drawing etc. shall not be copied, transcribed, traced or reproduced in any other form or otherwise in whole / part or duplicated, modified, divulged and / or disclosed, to a third party not misused, used in any other form whatsoever without purchaser's prior consent in writing except to the extent required for the execution of this order. At the time of tendering the purchaser has to give an undertaking in favour of G.R.S.E. that in the event of any breach of the above provisions, he would make good of any loss / cost / damage / any other claim whatsoever preferred by anybody to G.R.S.E. in this respect.
- 14. **PATENT RIGHT:** GRSE shall be completely absolved of any responsibility towards any infringement of Patent Right etc. i.e. a clear and quite possession of goods should take place with the passing of title on execution of the order.
- 15. **L.D. CLAUSE**: All orders are subject to LD @1/2% per week or part thereof on undelivered portion of the order subject to a maximum of 5% of total value of the order for the delayed part. To release L/D amount GRSE will have the right to encash / revoke the Security Deposit / Bank Guarantee.
- 16. **RISK PURCHASE:** If the materials are not supplied within the stipulated delivery period GRSE reserves the right to procure the same or equivalent material from alternative source at your risk, responsibility & cost.
- 17. **GUARANTEE**: 12 months from date of commissioning or 18 months from date of receipt of materials at GRSE whichever is earlier. A guarantee certificate is to be forwarded with the supply.
- 18. **TEST / GUARANTEE CERTIFICATE :** Manufacturer / Supplier's Guarantee Certificate indicating compliance of the specification, make, etc. is to be forwarded along with the supply of the items. Necessary catalogue, detail, etc. of the item as applicable, should be furnished by the firm to facilitate receipt inspection.

- 19. **PACKING:** All materials are to be properly packed to protect against ingress of water & dust and to withstand transit damages /pilferages during transits. All packing/cases should be properly identified and tagged.
- 20. **INSPECTION**: As per SOTR Point No.3 (vi).
- 21. **RIGHT OF INVOCATION OF BANK GUARANTEE**: GRSE reserves the right to invoke the Bank Guarantee at any time during its validity period in the event of failure / delay in supply / breakage any sorts of operational complication of ordered materials / breach of any terms of this contract.

22. PAYMENT TERMS : FOR VALUE OF ORDER GREATER THAN RS. 2 LACS —

- 23. **PERFORMANCE BANK GUARANTEE:** A Bank Guarantee, in a bank-sealed envelope, for 10% value of order, in GRSE's format on a non-judicial stamp paper of Rs.50.00, valid for guarantee period, must be furnished towards Performance Bank Guarantee before claiming of 100% payment.

- 24. **CONTRACT PERFORMANCE BANK GUARANTEE:** In the event of receipt of order, a bank guarantee of 5% of ordered value of the order, valid till execution of order, on a non-judicial stamp paper of Rs.50/- (as per GRSE Format) to be submitted within 14 days from the date of receipt of order. In case a single stamp paper of Rs.50/- is not available, stamp paper of multiple domination is acceptable provided serial no. of such stamps are consecutive and are purchased on the same date. - 25. **SUBMISSION OF DOCUMENTS**: For late submission of original despatch documents / wrong documentation, demurrage / wharfage charges if incurred, shall be recovered from the supplier.
- 26. **FORCE MAJEURE CLAUSE**: Standard Force Majeure Condition at the supplier's own works / establishment shall only be accepted. The failure of the sub-contractors of the suppliers shall not be accepted as a Force Majeure Condition. Vendor is to submit relevant proof / document well in advance to buyer.
- 27. **<u>DELIVERY</u>**: Our requirement is urgent. Firm must quote earliest possible delivery period from placement of LOA / P.O.

- 28. **REJECTION:** Rejection of materials and also the late delivery will affect further business with GRSE. No claim of payment will be entertained (for rejected material) in case rejected items are not lifted back within 14 days from the date of rejection. Replacement against rejection is to be made by vendor Free of Cost within 14 days of Store's intimation.
- 29. **CANCELLATION OF ORDER**: In the event of progress being poor & non-responsive, GRSE reserve the right to cancel the order applying risk purchase clause & no cancellation charges will be paid to the firm on this account.

30. **MODE OF DESPATCH:**

a) For local supplier:

To be delivered to GRSE at firm's own cost.

b) For out side supplier:

The items to be dispatched preferably through GRSE nominated transporter on freight paid & door delivery basis. The materials are to be suitably packed to avoid transit damage / pilferage.

Way bill: For arranging Way bill the firm has to submit the following documents to reach the ordering authority per courier:-

31. **ARBITRATION:**

- a) If, at any time, before, during or after the contract period, any unsettled claim, question, dispute or difference arises between the parties, upon or in relation to or in connection with or in any way touching or concerning this tender / agreement / supply order (retain whichever is applicable) the same shall be referred to the Chairman & Managing Director ("CMD" in short) or the Managing Director ("MD" in short), as the case may be of Garden Reach Shipbuilders & Engineers Ltd. ("GRSE Ltd." in short) for adjudication of the said disputes or differences, as sole arbitrator, in accordance with the provisions of arbitration and conciliation act, 1996.
- b) The CMD or MD, GRSE Ltd. if he so desires, may nominate / appoint another officer of GRSE Ltd. or a person, whom he thinks fit and competent, for adjudication of the disputes or differences, referred to him as the sole arbitrator.
- c) Such arbitration shall, in all respects, be conducted in accordance with the provisions of the arbitration and conciliation act, 1996 and the rules framed there under or any statutory modification or re-enactment thereof for the time being in force.
- d) The award of the sole arbitrator shall be final, conclusive and binding upon the parties.
- e) In the event of the death or resignation for any reason whatsoever of the said sole arbitrator, appointed by the CMD or MD of GRSE Ltd., the CMD or MD of GRSE Ltd., on an application from either of the parties in this behalf, shall act himself as the sole arbitrator or nominate / appoint, in place of the outgoing arbitrator, another officer of GRSE Ltd., or a person whom he thinks fit and competent to adjudicate the said disputes and differences in accordance with law.

- f) Also in the event of arbitration award is set aside by a competent court on an application from either party and unless otherwise ordered by the said court, the CMD or MD of GRSE Ltd., on an application from either party, shall himself act as sole arbitrator or nominate / appoint another officer of GRSE Ltd., or a person whom he thinks fit and competent to adjudicate the disputes and difference in accordance with law.
- g) The cost of the arbitration, fees of the arbitrator, remuneration of the stenographer and clerk, stamp paper etc., as shall be decided by the sole arbitrator, shall be shared equally by the parties. The venue of arbitration, unless otherwise decided by the parties or by the sole arbitrator himself, shall be the premises of the Garden Reach Shipbuilders & Engineers Ltd. located at 43/46, Garden Reach Road, Kolkata -700024.
- 32. **JURISDICTION:** All disputes arising out of the contract if required to be referred to a court of law, the jurisdiction of the case would be under Kolkata court irrespective of the location of the vendor.
- 33. **COMPLIANCE WITH LAWS**: Vendor is warranted that all goods purchased against the enquiry shall conform with all applicable city, States and Central Laws, Ordinances and Regulations. Further, Vendor shall indemnify / defend / relieve GRSE harmless from loss, cost of damage, by reason or any actual or alleged violation thereof.
