# SCOUTER MOUNTAIN ELEMENTARY GENERAL PTA MEETING <br> September 15, 2011 

## MEETING CALL TO ORDER:

The general PTA Business meeting of your school PTA was called to order in the library at 6:30 p.m. on Thursday, September 15, 2011 by President, Sally Curran. Sally asked everyone in attendance to introduce themselves.
OPENING CEREMONIES:
Sally Curran opens the ceremony with the PTA mission:

Sally Curran discussed the beginning of the year business. This included the Standing Rules, Established Quorum based on Standing Rules, Financial Procedures, and Proposed Budget.
ESTABLISH QUORUM:

## STANDING RULES:

FINANCIAL PROCEDURES 2011-2012:

## PROPOSED BUDGET:

The PTA gave the Teachers'Assistants $\$ 7,000$ this year due to the larger classroom sizes and each teacher an Education Stipend. Karen Wachhaus motioned to approve the proposed budget and Linda Parsons seconded. Everyone voted to accept the proposed budget as written with show of hands.

## APPROVAL OF MINUTES:

Sally Curran presented the minutes of the general meeting held on May 19, 2011, and asked if there were any corrections/additions to the minutes. The minutes stand approved as written.

## CLACKAMAS COUNTY SHERIFF'S DEPARTMENT PRESENTATION:

Clackamas county sheriff (do not have his name) indicated that in current year Sheriffs' Department is spending budget wisely and fighting new threats on the internet. As well, Sheriff's Department identifying savings to make levy and general fund budget more effective. Ask everyone to exercise the constitutional right to vote for Clackamas County.

Jennifer Brown presented and reviewed the treasurer's report. As well as reminded everyone to fill out application for the Safeway club card in order for school to earn $\%$ from it.

We will take orders for new hoodie sweatshirts, shirts, etc. for the whole family throughout the year. Anyone who volunteers to create new design for the school T-shirts please bring your voice up.
Jon-A-Thon fundraiser is being chaired by Lori Larson, she explained how the even has been planned.
Linda Parsons informed that we have 75 members now and our goal is to get 136.
Kelly Horn presented "I made this" products and the process of program. Student's art work is turned into unique gifts that you can purchase for your family and friends. There are items such as tote bags, mugs, cards, t-shirts, etc. Orders are due on November 11, 2011 and products will arrive the second week of December, 2011, right before the Christmas break.
