Headquarters Buildings – Old and New

Many of you may have heard that Sempra Energy is building a new corporate headquarters in the East Village, near Petco Park. This is the first in a series of articles about that move, starting with some history of the current headquarters at 101 Ash Street.



101 Ash Street, on the corner of First Avenue and Ash Street in downtown San Diego, is the current location of Sempra Energy's headquarters. But before it was Sempra's HQ, it was known as the Electric Building, or EB, the headquarters of SDG&E.

Opening in 1968, the building was designed by Richard W. Wheeler. It is 19 stories, with two underground levels for executive and director parking. The old EB not only housed SDG&E's corporate and support employees, but had a full-demonstration kitchen in an auditorium where cooking classes were given to our customers. It also had a bill payment office with an auto-teller allowing customers to drive-in to the A Level and "send" their payments via a pneumatic tube up to the first floor. And all gas and electric bill payment processing was done on site in our Cash Control department.

SDG&E shareholders meetings were held each April in the Auditorium and a full-service cafeteria was located on the third floor, providing breakfast, lunch

Help For Seniors

2-1-1 San Diego understands the needs of the community and believes that all people deserve to live healthy, happy and thriving lives.

Through more than 400,000 annual connections with customers, 2-1-1 serves the entire population of San Diego and Imperial counties as the region's primary connection to more than 6,000 community, health and disaster services. In more than 200 languages and dialects, 24 hours a day, they provide connections to services ranging from food assistance, healthcare information, services for families, children and seniors, military and veterans.

By dialing 2-1-1, customers are linked to a live, highly-trained Customer Service Representative (CSR), who helps clients navigate resolutions to their needs using assessment and motivational interviewing. This helps to match them to the best and closest resource in their community and empower them to take the next step.

During a disaster, 2-1-1 serves as the region's connection to community and support services, providing public information to the community, rumor control and trend analysis to public safety officials. They also report community needs, relieving the burden on 9-1-1 operators, and serve as the central communications point for other agencies and organizations.

For our nonprofits, community-based agencies and governmental entities, 2-1-1 can alleviate administrative burden and reduce costs associated with managing information and referral services. This allows these organizations to focus on serving, rather than finding clients. In addition, 2-1-1 is a trusted data provider to help local government, business and nonprofit leaders make informed funding and planning decisions.

Since its inception, 2-1-1 San Diego has provided information and resources to seniors in San Diego. Formerly known as InfoLine, SDG&E has been a major supporter through its Corporate Community Relations department for many years. As the community becomes more aware of the special needs of our senior population, 2-1-1 aims to reduce the

many barriers to finding services by providing an easy-to-remember three digit dialing code.

2-1-1 relies on the generous philanthropic support of corporations, foundations and individual donors who recognize the value of both the critical connections to services, and the important data on community needs and resources collected by the organization. This support is critical in helping 2-1-1 put resources at the fingertips to those that need them most.
