<u>Note</u>: 1. Recruitment for 103 posts is subject to approval of Competent Authority. The number of vacancies are subject to variation due to administrative reasons. The Admiral Superintendent, Naval Dockyard, Visakhapatnam has the right to cancel the advertisement/recruitment at any stage due to administrative reasons

2. Horizontal reservation of 10% for Ex-Serviceman, 03% for Persons with Disability (PWD) and 05% for Sportsmen (i.e., who have represented a State/Country/University/State School Team in the National or international level or Sportsmen who have been awarded National Awards in Physical Efficiency under the National Physical Efficiency Drive) is applicable for the above posts. Accordingly, <u>30</u>, <u>09</u> and <u>15</u> posts are reserved for Ex-Serviceman, PWD and Sportsmen respectively. Horizontal reservation for Persons with Disability [Orthopedically Handicapped (OH) + Hearing Handicapped (HH) + Visually Handicapped (VH) (Blind)] is available (with 40% and above relevant disability) and candidates selected for appointment will be placed against the category to which they belong.

2. <u>Age/Age Relaxation</u> (upper age limit):- The upper age limit for UR candidates will be 25 years as on the last date of receipt of applications. This is relaxable by 03 (three) years for OBC, 05 (five) years for SC/ST and 10 (ten) years for PHC candidates against reserved vacancies. The upper age limit is also relaxable for Government servants upto 35 years in accordance with instructions or orders issued by Central Government from time to time in this regard. The upper age limit is relaxable upto a maximum of 05 years (10 years in the case of those belonging to Schedule Castes and Scheduled Tribes) for Sportsmen. (c) The above standards are applicable for all categories of candidates including PHC (HH and VH) and Ex-Serviceman. PHC (OH) may be exempted from PET. However, they are to be present at the venue at the schedule of the PET.

(d) The responsibility/liability for any damage, during the course, in the form of injury or any causality rests with the candidates attended for PET and the administration is not responsible/liable in any case.

(e) Candidates cleared PET are required to appear for the written examination consisting of 100 objective type questions prepared based on 10th standard syllabus comprising of General Science, Maths and General Knowledge. The question paper will be provided in English language only.

(f) Merit list will be prepared based on the marks obtained in the written exam.

(g) Candidates will be called for verification of original certificates and undergo Medical Examination as per the merit list till vacancies are filled up.

5. IMPORTANT/GENERAL INSTRUCTIONS:

(a) Only Indian Nationals can apply for the above posts.

(b) The eligibility in respect of age, educational qualifications, etc., will be determined as on the closing date of receipt of applications.
