**Digital Images** are accepted on CD or as attachments to e-mail in JPG format only, no larger than 1MB. Clearly label CD with artist name, title, media, size (H x W x D) to correlate with entry form.

Images of work submitted will not be returned and if accepted by judge may be used for PR purposes. Selected pieces must be available for the entire show. All artwork must have a declared value for insurance purposes. If not for sale, note NFS along with declared value.

**Eligibility**

Open to artists 18 years of age and older, living in the southeast regions of the United States. All forms of art including painting, drawing, sculpture, photography, graphics and ceramics are accepted. Work must have been complete after Jan 1, 2009. Work must be original and entirely the work of the artist, without supervision of an art instructor. Pieces should not exceed 65 inches in any direction, including the frame. Installations are not eligible. Entries that have won an award in a previous ADSO exhibition are not eligible.

Work that differs from the original image submitted will not be accepted. No changes in the title, sale price or value may be made after the selection process. Accurate, legible information is to be provided with the application.

**Liability**

All work is insured while at the Mattie Kelly Arts Center Galleries. ADSO and the NW Florida State College, their officers, employees, directors, members, volunteers or anyone connected with the exhibition will not be liable for damages during shipping. We suggest artists carry their own insurance for this purpose. Damaged shipping containers will be returned unopened. Signature on entry form indicates agreement with these conditions.

**Awards**

Prize money will total \$2,000.

As a *special award* for the first-place winner, a one-person show may be arranged in the Holzauer Gallery of Mattie Kelly Arts Center Galleries during the 2012 Southeast Regional Juried Fine Arts Exhibition.

**Standards**

Accepted entries must be ready for gallery installation. Framed, two-dimensional pieces must be properly matted with a heavy wire attached securely to the back. Plexi-glass is recommended for shipping. 3-D pieces must be able to be handled comfortably by two people. Any piece requiring assembly must be assembled by the artist at a time arranged with ADSO.

Selected artists will be asked to provide a short resume or artist's statement for education and publicity purposes.

Artwork must be shipped, prepaid, via UPS or FedEx in a sturdy, reusable carton to arrive by noon on April 21. All shipments must comply with UPS/FedEx size and weight restrictions.
