#### Overview

This is the 18th Annual Living with Grief Program from the Hospice Foundation of America and Hospice of the Bluegrass. This year's focus is "Spirituality and End-of-Life Care."

We will view the Hospice Foundation of America's national program via DVD. An interdisciplinary panel of experts will discuss the ways that spiritual issues and spiritual coping may emerge throughout an illness, the importance of spiritual assessment, approaches to meaning-making at end of life and sensitivities to the particular concerns of major faith systems toward end-of-life care.

- 4. Describe varied approaches to spiritual assessment as well as sensitivities to be considered.
- 5. Evaluate approaches towards helping clients through meaning-making and spiritual practices, including reminiscence, life review, rituals, beliefs and faith communities.
