

On behalf of the facility owner, ATCO Energy Solutions, ATCO Electric is advising neighbouring landholders, agencies and other interested parties about plans to install new equipment at the existing Scotford upgrader substation.

The substation is located approximately 13 kilometres northeast of the City of Fort Saskatchewan on the northwest quarter of Section 32-55-21 W4M (please see the map above).

This package provides important project information and outlines ATCO Electric's public consultation process. We invite any comments, questions or concerns you may have. Please refer to the back page for our contact details.

Project Need and Details

Minor alterations to the existing Scotford upgrader substation are needed to provide reliability and meet an increased demand for electricity associated with future industrial development.

If approved, this work will include the replacement of existing equipment with two 138/34.5-kilovolt (kV) transformers and the installation of two 35-kV air core reactors, associated switches and equipment (please see the enclosed site layout). All planned construction activities will be occurring within the substation site boundary.

The Process

ATCO Electric will be contacting everyone in the vicinity of the Scotford upgrader substation. Once input has been received, ATCO Electric will file an application for the project on behalf of ATCO Energy Solutions with the Alberta Utilities Commission (AUC) seeking approval for the substation alterations described.


Alberta's electrical system is regulated by the AUC. The AUC is a quasi-judicial agency that ensures the services provided by ATCO Electric and other Alberta utilities take place in a fair and responsible manner and are in the public's interest. Before ATCO Electric can begin construction on a project, the AUC must approve the facilities application, which includes details such as the planned substation alterations.
