A7 Outline of Proposal/Development(s)

Advanced Physiotherapy Practice

The Advanced Physiotherapy Practice Programme has been a part of the postgraduate health care provision at Manchester Metropolitan University since its first re-validation in 2004, having previously been within the Manchester School of Physiotherapy. The only major modification since then has been to add "(post-registration)" to the award titles for the MSc Physiotherapy programme, to distinguish it from the MSc Physiotherapy (pre-registration) programme, when that was validated in 2006.

The proposed incorporation of this programme into the CP3d Framework includes:

The introduction of four new elective units for the Advanced Physiotherapy Practice

- Programme awards and as CPD stand-alone (modular) units within the Framework, to make the programme appeal to a wider range of clinicians.
- The re-structuring of the credit rating of some existing units within the Advanced Physiotherapy Practice programme to make them more accessible to modular students and to respond to changes in musculoskeletal physiotherapy management.
- The amendment of the Masters level assessment grading criteria (including regulatory updating) to bring the programme fully into line with MMU Regulations for Taught Postgraduate Programmes of Study.
- The introduction of an additional 'by research' route to the MSc Physiotherapy (post-registration) award to enhance personal and professional development, recognise the increasing contribution that physiotherapists are making to the NHS research agenda and stimulate some students to aspire for a PhD or Professional Doctorate.

Social Work PQ Awards

Key features of this proposal:

- There will be three subject specialist routes in line with the GSCC accredited areas: 'Children, Young People, their Families and Carers', 'Leadership & Management' and 'Social Work with Adults'.
- The assessment of all the units within this programme is to include academic and practice assessment and elements of work-based learning, to meet GSCC requirements.
- The Higher Specialist Award (PgDip) level will comprise three core units (20 credits each) for all students and a further three 20 credit units from the subject specialist route, or an approved combination of subject specialist units with selected units available within the wider CP3d framework and the Institute of Education.
- The Advanced Award (MA) level will build on the above with a 20 credit research methods unit and a 40 credit research dissertation.
- Units from this programme will also be available to individuals and employers from related professional groups as discrete post-registration training / CPD units (thus promoting inter-professional learning).

A10 Conclusions on Innovation and Good Practice

The Panel identified the following aspects of good practice:

Advanced Physiotherapy Practice

- 1. The quality of student support, of which the students spoke very highly.
- 2. The flexibility of the programme to suit diverse student needs.
- 3. The extent to which the programme had developed students' critical thinking skills.
- 4. The development of the programme so that it can be incorporated into the CP3d Framework.

Social Work PQ Awards

- 1. The strong relationship with service users
- 2. The strong and robust proposal supported by very good liaison at regional and local level.
- 3. The very good breadth and diet of units overall

CP3d Framework

- 1. The well-organised and presented documentation.
- 2. The good example of collaborative working illustrated.

A11 Conclusions on Quality and Standards

The Panel concluded that the intended learning outcomes of the proposed Social Work PQ Awards were achievable by students and appropriate to the standards of the University's awards and that the programme was current and valid in the light of developing knowledge in the discipline and developments in teaching and learning.

The Panel concluded that the intended learning outcomes of the Advanced Physiotherapy Practice programme were being achieved by students, that the standards of the University's awards were being maintained and that the programme as modified remains current and valid in the light of developing knowledge in the discipline, practice in its operation and

developments in teaching and learning.

Initial and continued approval with effect from September 2009, subject to fulfilment of the five conditions in Section A13 below.

A13 | Condition(s) of Approval

The following conditions of approval must be fulfilled before the programme/modified programme may commence:

Advanced Physiotherapy Practice

- 1. MSc by Research
 - a) There should be specific route entry-requirements, to ensure students have sufficient practice and research understanding to allow them to meet the programme learning outcomes.
 - b) That the dissertation unit proformas for the MSc by research routes should be revised to contain more specific learning outcomes and assessment criteria; the latter may be contained in section 2.3.
 - c) Both learning outcomes and assessment criteria should be consistent with equivalent dissertation units within CP3d Framework.
- 2. Rules for condonement should be made explicit in unit proformas.
- 3. Include a CRB check and health screening as an admissions requirement for the MSc Manual Therapy programme.
- 4. Give more clarity to the research project component within the "Clinical Placement: Upper Quadrant" unit to meet MACP requirements.

Social Work PQ Awards

1. Amend the titles of the PgDip and PgCert post-qualifying awards to the satisfaction of the University and the GSCC.

Advanced Physiotherapy Practice

Social Work PQ Awards

1. Consider the development of a Service Level Agreement to formalise service user and carer involvement.

CP3d Framework

- 1. Monitor the integration of Advanced Physiotherapy Practice and post-qualifying Social Work programmes into the CP3d Framework.
- 2. Continue to monitor the way in which unit information and availability is communicated to students.
