A7	Outline of Proposal/Development	
	<p>The Master of Research is a successful, existing programme within the Business School, recognised as a 'model' MRes by the ESRC. The MRes was first validated in 2001 and last reviewed in 2004. The programme aims to develop competent social researchers, capable of undertaking successful doctoral study or a career in research. It aims to provide advanced training in research methods and underlying concepts for students in Business and Management through introduction to the principles of research incorporating the philosophy of knowledge, qualitative and quantitative methods and a critical literature review. This periodic Review was scheduled to take place during 2006-07 but was formally deferred to 2007-08 with the agreement of the Faculty Research Degrees Committee due to illness of key staff.</p> <p>At this Review the Panel is asked to approve a number of changes to the existing programme, these include the following: The removal of the cognate discipline unit (students usually claim exemption). The units are now all worth 20 credits (previously some at 10 credits). The delivery and scheduling of the programme is to be altered to block sessions of individual units. The attendance requirements of part-time and full-time students will become more distinct, providing more focus and clarity for each group. The development and use of Web CT and action/ blended learning.</p>

This will be accompanied by a redesigned assignment feedback sheet that included a series of prompted sections for more prescriptive feedback for the students, including a section that outlines how the assignment could be improved.
2. That the reading lists on the unit specifications are thoroughly revised and updated.

A15 Recommendations

The Programme Team must consider and address explicitly the following recommendations in the course of its annual monitoring processes:

1. The Panel recognised that to achieve the required depth and quality of blended learning materials (WebCT) prior to the start of the revised programme would require much staff development and would thus be resource intensive. The Panel recommended to the Faculty that sufficient priority of resources were made available for this development to be successfully introduced. The Panel requested that any problem or issue concerning the provision of resourcing this development was referred to the Chair.
2. The student induction programme is reviewed and explicit information is provided upon the following issues: inter-library loans; the SCONUL Access Scheme; the availability of statistical software packages (and the support available for these); the provision of English language support; details of the International Students Support Officer; clarity of other support mechanisms available.

This information could, for instance, be provided via a student handbook at the beginning of the programme.

A16 Date of next scheduled review

The next scheduled periodic review of the programme will be held during the Autumn term of 2012-13 academic year.

	<p>1. That the Programme team create a systematic procedure to regulate tutor assessment feedback on student assignments, ensuring that the level and depth of this feedback is more uniform and consistent than currently exists. A section that outlines how the assignment could be improved has been added and a separate sheet including prompted sections for more prescriptive feedback has been added.</p> <p>A programme team meeting will be held to present and discuss the new system for assessment feedback and to ensure shared understanding of the terms and expectations before the programme begins in September 2008.</p> <p>2.
