Note: (i).The distribution of seats will be decided at the time of counseling which will be displayed on notice board subject to any change by BFUHS/Punjab Govt.

# 2. Eligibility:-

(i) The eligibility of the candidates is as per the criteria laid down in the Punjab Govt. Notification No.2/100/2009-3HB3/6734 dated 24.12.2009 and its amendment from time to time.

(ii) Candidates should have obtained B.P.T. from a recognized institution. First preference will be given to the bonafide residents of the State of Punjab. The bonafide Resident status of the Punjab State will be taken in terms of Punjab Govt. Department of Personnel and Administrative Reforms (PP II Branch) letter No. 1/3/95-3PP-II/9619 dated 6<sup>th</sup> June, 1996, ID No. 1/2/96-3PP-2/8976 dated 7<sup>th</sup> July, 1998 and ID No. letter No. 1/3/95-3PP II/81 dated 1<sup>st</sup> January, 1999 and further instructions issued by the Department. The candidates from other states shall also be taken, if Punjab candidates are not available. Condition of bonafide residents of the State of Punjab shall not be applicable to the candidates belonging to the following categories of Punjab residents:-

- 1. Children/ wards/ dependents (whose parents are not alive) of all those Punjab Government employees, members of All India Services borne on Punjab cadre, of Judges and employees of the Punjab and Haryana High Court, employees Boards/Corporations/Statutory Bodies established by an act of the State of Punjab who have remained posted outside Punjab for at last three years out of the five years preceding the year of admission and their wards because of their posting outside Punjab had to do BPT from an institution outside Punjab.
- 2. Children/ wards/ dependents (whose parents are not alive) of all those Central employees, employees of Boards/ Corporations/ Statutory Bodies established by an Act of the Central Government who have remained posted inside Punjab for at least three years out of the five years preceding the year

of admission and their wards because of their posting outside Punjab had to do BPT from an institution outside Punjab.

- 3. Children/ wards/ dependents (whose parents are not alive) of all those Punjab Government pensioners who have remained posted outside Punjab for three years out of the five years preceding the year of admission and have settled outside Punjab.
- 4. Children/ wards/ dependents (whose parents are not alive) of military/para military forces personnel who were born in the territory of Punjab as per their service record at the time of entry into the service.
- 5. Children/ wards/ dependents (whose parents are not alive) of Ex-employees of military/para military forces who were born in the territory of Punjab as per their service record at the time of entry into the service and have retired within five years preceding the year of admission and have settled outside Punjab.

(iii) The admission will be made on the basis of merit of aggregate marks in BPT examination.

(iv) In case of a tie between two or more candidates having equal marks in BPT, the interse ranking of such candidates shall be determined by the following factors in the order of precedence:-

- a) Candidate with higher marks in the final year examination.
- b) Candidate older in age.

(v) The allotment of specialty in college shall be made by the Admission Committee on the basis of the inter se merit obtained by the candidate. Personal appearance in the counseling/ interview of the candidate shall be compulsory.

# 3. Selection/Admission Procedure:

All candidates who fulfill the eligibility criteria and other conditions, should submit an application form for admission in the office of University College of Physiotherapy, GGS Hospital Complex, Sadiq Road, Faridkot. Applications received after the due date / time for any reason including postal delays will be rejected. The University will not be responsible for any delay or loss in transit caused by Postal Dept./Courier Services or anyone else.

The Selection of candidates will be made by the Admission Committee as per schedule of given advertisement. The selected candidates have to deposit fees on the spot on the day of counseling.

**Explanation:** The following points shall be observed while granting reservation:

- A candidate under handicapped category shall be admitted only if he or she has loco motor disability of lower limbs between 50% to 70% and with this disability he/ she is otherwise found fit medically to pursue the concerned course by the Medical Board duly constituted by the Government.
- (ii) The above reservation will be made in the above institutions subject to availability of seats as per instructions issued by the Government of Punjab from time. The reservation shall not exceed 25% in case of SC and 30% in case of SC and BC combined together.
- (iii) Candidates belonging to reserved category will be eligible for admission as per their combined merit in General category also, if they opt for the same.
- (iv) Seats remaining vacant under any of the reserved category shall be merged with the general category seats and vice-versa.

## 5. The candidates should bring the following documents

- V. Certificate that BPT examination has been passed as a regular student from a recognized Institution /Board/University in the state of Punjab or other State.
- VI. Exemption certificate under clause 7 (a) to (e) of Punjab Govt. Notification, in case BPT passed from outside Punjab.
- VII. Detail Marks Certificate of 10+1 and 10+2 (both) or equivalent examination.
- VIII. Matriculation certification showing Date of Birth.

- IX. Character/ Conduct certificate from the Institution last attended.
- X. Punjab Residence Certificate.
- XI. Certificate of Reserved category from the competent authority, if any reservation is claimed.
- XII. Gap in studies affidavit, if applicable.
- XIII. Migration certificate, if passed BPT or equivalent from Board/University other than BFUHS.
- XIV. Service Experience certificate.
- XV. Five unattested copies of the same stamp size photographs (after selection).

## **6.** Medical examination:

Each selected candidate is required to report for medical examination on dates which will be notified at the time of counseling and also bring with them the original Certificates/ documents as mentioned above.

# 7. Tuition Fee & Other charges

An annual tuition fee of Rs. **50,000/-** will be charged as decided by the university committee.

# 8. General Information:

- 1. The Hostel is not compulsory. All admissions are provisional and are subject to approval by Baba Farid University of Health Sciences, Faridkot.
- 2. The courses of study and examinations will be governed by the regulations of BFUHS, Faridkot.
- 3. Attendance in these classes is compulsory.
- 4. The competent authority have the right to revise any Rules and Regulations, including fees

## 5. Very important regarding Ragging:-

Ragging is strictly banned inside/outside the Campus and is a criminal offence. Ragging is strictly banned by the Govt. of India/Supreme Court of India/other authorities. Now a days "Ragging" is synonym of Teasing, abusing, playing practical jokes, threatening, harassment, cruelty, fear, physical and mental torture.

6. "If any incidence of ragging comes to the notice of the authorities, the concerned students shall be given liberty to explain and if his/her explanation is not found satisfactory, the authorities would expel him/her from the institution."

In case the victim of ragging, his/her parent/guardian is not satisfied with the action taken by the College authorities or College authority is of the opinion that incident ought to be so reported, a First Information Report (FIR) with local Police authority shall be filed.

- 7. Misbehavior/ criminal activity of student will attract expulsion from the institution.
- 8 Mobile phone is not allowed in college, if found will be confiscated and will be returned only to parents for first time, second time it will not be returned at all.
- 9. The tuition fee and other charges for the year will have to be deposited at the time of admission before start of classes.
- 10. The students will have to pay the fee for entire course (2 years) if he/she left the course / vacated the seat after the cut off date for admission.
