# I. Introduction

1. At its 1st and 2nd meetings, on 15 September 2004, the General Committee considered a memorandum by the Secretary-General relating to the organization of the fifty-ninth regular session and future sessions of the General Assembly, the adoption of the agenda and the allocation of items (A/BUR/59/1) together with a letter from the President of the fifty-eighth session of the General Assembly to the President of the fifty-ninth session of the Assembly (A/59/355). A summary of the discussions will appear in the summary records of the meetings (A/BUR/59/SR.1 and 2).

2. The General Committee took note of the provisions of the following resolutions which are reflected in the present document under the relevant sections:

(a) Annex I (Guidelines on the Rationalization of the Agenda of the General Assembly) to General Assembly resolution 48/264 of 29 July 1994, entitled "Revitalization of the work of the General Assembly";

(b) The annex to General Assembly resolution 51/241 of 31 July 1997, entitled "Strengthening of the United Nations system";

(c) Paragraph 1 of General Assembly resolution 52/163 of 15 December 1997, entitled "Amendment to rule 103 of the rules of procedure of the General Assembly";

(d) The annex to General Assembly resolution 55/285 of 7 September 2001, entitled "Revitalization of the General Assembly: improving the efficiency of the General Assembly";

(e) General Assembly resolution 56/509 of 8 July 2002, entitled "Amendments to rules 30, 31 and 99 of the rules of procedure of the General Assembly";

(f) General Assembly resolution 57/301 of 13 March 2003, entitled "Amendment to rule 1 of the rules of procedure of the General Assembly and opening date and duration of the general debate";

(g) General Assembly resolution 58/126 of 19 December 2003, entitled "Revitalization of the work of the General Assembly";

(h) General Assembly resolution 58/316 of 1 July 2004, entitled "Further measures for the revitalization of the work of the General Assembly".

3. The General Committee also took note of the report of the Secretary-General on the reform of the United Nations, entitled "Strengthening of the United Nations: an agenda for further change" (A/58/395 and Corr.1).

# **II.** Organization of the session

#### A. General Committee

4. The General Committee took note of rule 40 of the rules of procedure and document A/56/1005 (annex, paras. 9 and 10) pertaining to the functions of the Committee.

5. The General Committee also took note of paragraph 5 of the annex to General Assembly resolution 58/316 pertaining to the functions of the General Committee, in particular, subparagraphs (d) to (h), which read:

"(*d*) In July of each year, the General Committee shall conduct a review of the proposed programme of work for the forthcoming session of the General Assembly, on the basis of a report to be submitted by the Secretary-General, and submit recommendations on the matter to the forthcoming Assembly. The report of the Secretary-General shall include information on the status of documentation to be issued during the forthcoming session;

"(*e*) The General Committee, meeting in open-ended consultations, shall continue to consider the further biennialization, triennialization, clustering and elimination of items of the customary agenda of the General Assembly and make recommendations thereon to the Assembly during its fifty-ninth session;

"(f) On the basis of proposals from the President of the General Assembly, and in the light of the positive experience during the fifty-eighth session, the General Committee shall be encouraged, as appropriate, to continue to schedule informal briefings on topical issues;

"(g) At the beginning of each session, the General Committee, following recommendations from the President of the General Assembly, shall recommend to the Assembly a programme of, and format for, interactive debates on the items on its agenda;

"(h) The General Committee shall continue to consider ways and means to further improve its working methods to increase its efficiency and effectiveness in all aspects, and make recommendations on the matter to the General Assembly for its decision by 1 April 2005."

6. The General Committee also took note that at the outset of each session, each Vice-President of the General Assembly should designate a liaison person for the duration of the session (resolution 55/285, annex, para. 20).

# **B.** Rationalization of work

7. The General Committee took note of the following General Assembly resolutions and report of the Secretary-General in relation to the administrative and financial functioning of the Organization:

(a) Resolution 41/213 of 19 December 1986, entitled "Review of the efficiency of the administrative and financial functioning of the United Nations";

(b) Resolution 48/264 of 29 July 1994, entitled "Revitalization of the work of the General Assembly";

(c) Resolution 52/12 B of 19 December 1997, entitled "Renewing the United Nations: a programme for reform";

(d) Resolution 58/126 of 19 December 2003, entitled "Revitalization of the work of the General Assembly";

(e) Resolution 58/316 of 1 July 2004, entitled "Further measures for the revitalization of the work of the General Assembly";

(f) Report of the Secretary-General on the review of the efficiency of the administrative and financial functioning of the United Nations (A/56/82).

8. The General Committee also took note of paragraph 14 of the annex to General Assembly resolution 55/285, which reads as follows:

"14. As regards implementation of paragraph 7 of the annex to resolution 51/241, the President of the General Assembly, after consideration by the Assembly of the report of the Secretary-General on the work of the Organization, shall inform the Assembly of his assessment of the debate on the report in order for the Assembly to determine the need for further action."

9. In connection with the effort to rationalize the work of the General Assembly, the General Committee took note of paragraph 2 of section B of the annex to resolution 58/316.

10. The General Committee also took note of paragraph 1 (a) of the annex to resolution 58/316, which reads:

"(*a*) The consideration of the implementation of paragraph 2 of section B of the annex to resolution 58/126 shall be deferred until its fifty-ninth session, taking into account the views expressed as well as the suggestions made by Member States in the context of the deliberations of the open-ended meetings of the General Committee during the fifty-eighth session".

11. The General Committee draws to the attention of the General Assembly paragraph 3 of the annex to resolution 58/316 pertaining to the practices and working methods of the Main Committees.

12. The General Committee also draws to the attention of the General Assembly that the Main Committees shall meet in substantive session only after the end of the general debate and that the First Committee and the Fourth Committee shall not meet simultaneously and may consider meeting in a sequential manner during the regular session of the General Assembly. This arrangement shall not apply if it affects their respective identities, programmes of work and effective consideration of their agendas (resolution 51/241, annex, paras. 31 and 36).

# C. Opening and closing dates of the session

13. The General Committee recommends to the General Assembly that the fiftyninth session of the Assembly recess on Tuesday, 14 December 2004, and close on Monday, 12 September 2005 (rule 2 of the rules of procedure and paragraph 4 of annex V to the rules of procedure).

14. The General Committee also recommends to the General Assembly that, during the main part of the session, the First, the Special Political and Decolonization (Fourth) and the Sixth Committees complete their work by Thursday, 11 November, the Third Committee by Wednesday, 24 November, the Second Committee by Tuesday, 7 December and the Fifth Committee by Friday, 10 December 2004.<sup>1</sup>

# **D.** Schedule of meetings

15. The General Committee took note of the fact that in view of financial constraints, meetings at Headquarters are no longer serviced beyond 6 p.m. or on weekends, with the exception of the plenary of the General Assembly and the Security Council. Consequently, meetings of the Main Committees during the fifty-ninth session, including informal meetings, should start promptly at 10 a.m. and be adjourned by 6 p.m. during weekdays.

16. The General Committee recommends to the General Assembly that, during the final two weeks of Ramadan, from 1 to 11 November 2004, when local time will be Eastern Standard Time, the hours of the plenary meetings and the meetings of the Main Committees should be from 9.30 a.m. to 12.30 p.m. and from 2.30 p.m. up to 5.30 p.m. at the latest.

17. The General Committee took note of paragraph 1 (b) of the annex to resolution 58/316, which reads:

"(b) With effect from the fifty-ninth session of the General Assembly, the meetings of the plenary Assembly shall normally be held on Mondays and Thursdays."

18. The General Committee also took note of the fact that measures introduced to reduce costs relating to overtime would be strictly enforced.

19. The General Committee recommends to the General Assembly that, in accordance with past practice, it waive the requirement that at least one third of the members of the Assembly in the case of plenary meetings and one quarter of the members of a Main Committee in the case of Main Committee meetings be present in order to declare a meeting open and to permit the debate to proceed. This recommendation is made on the understanding that such a waiver would not imply any permanent change in the provisions of rules 67 and 108 of the rules of procedure and that the requirement of the presence of a majority of the members for any decision to be taken would be maintained.

## E. General debate

20. The General Committee draws to the attention of the General Assembly that the general debate in the Assembly shall open on the Tuesday following the opening of the regular session of the Assembly, that the general debate for the fifty-ninth session shall open on Tuesday, 21 September 2004, and end on Friday, 1 October 2004, that the general debate shall be held without interruption over a period of nine working days, and that the list of speakers for each day shall be completed and no speakers will be rolled over to the next day, notwithstanding the implications for hours of work. Furthermore, there shall be no time limits or specified themes for the general debate but the General Assembly will indicate a voluntary guideline of up to fifteen minutes for each statement (resolution 57/301, para. 2).

# F. Conduct of the meetings, length of statements, explanations of vote, rights of reply, points of order and concluding statements

21. The General Committee draws the attention of the General Assembly to the relevant rules of procedure regarding the conduct of meetings, namely, rules 35, 68, 72, 73, 99 (b), 106, 109, 114 and 115.

22. The General Committee also draws to the attention of the General Assembly that explanations of vote should be limited to ten minutes; that when the same draft resolution is considered in a Main Committee and in plenary meeting, a delegation should, as far as possible, explain its vote only once, i.e., either in the Committee or in plenary meeting, unless that delegation's vote in plenary meeting is different from its vote in the Committee; and that delegations should exercise their right of reply at the end of the day whenever two meetings have been scheduled for that day and whenever such meetings are devoted to the consideration of the same item (decision 34/401, paras. 6-8 (A/520/Rev.15, annex VI)).

23. The General Committee recommends to the General Assembly that points of order be limited to five minutes.

24. The General Committee also recommends to the General Assembly that it review the recommendations contained in paragraph 22 of the annex to resolution 51/241 and paragraph 23 of document A/52/855, regarding the length of statements with a view to streamlining the procedures of the General Assembly and as another cost-saving measure.

25. The General Committee further recommends to the General Assembly that, in order to save time at the end of the session, the practice of making concluding statements in the General Assembly and its Main Committees should be dispensed with except for statements by the presiding officers (decision 34/401, para. 17 (A/520/Rev.15, annex VI)).

# G. Records of meetings

26. The General Committee took note of the fact that, as at past sessions, during the fifty-ninth session verbatim records will continue to be provided for the plenary meetings of the General Assembly and the meetings of the First Committee, and summary records will be provided to the other Main Committees of the Assembly and the General Committee (see A/BUR/59/1, para. 27).

27. Furthermore, the General Committee draws to the attention of the General Assembly that the practice of reproducing statements in extenso as separate documents shall be discontinued for all its subsidiary organs that are entitled to summary records and that any exceptions to this rule may be made by the body concerned only if the statements are to serve as bases for discussion and if, after hearing a statement of the relevant financial implications, the body decides that one or more statements in extenso may be included in the summary record, or reproduced as separate documents or as annexes to authorized documents (resolution 38/32 E of 25 November 1983, paras. 8 and 9).

28. In this connection, the General Committee recommends to the General Assembly that the practice not to reproduce in extenso statements made in a Main Committee be maintained for the fifty-ninth session.

### H. Resolutions

- 29. The General Committee brings to the attention of the General Assembly that:
  - Whenever possible, resolutions requesting the discussion of a question at a subsequent session should not call for the inclusion of a separate new item and such discussion should be held under the item under which the resolution was adopted (decision 34/401, para. 32 (A/520/Rev.15, annex VI)).
  - "Efforts should be made to reduce the number of resolutions adopted by the General Assembly. Resolutions should request reports of the Secretary-General only in cases where that would be indispensable for facilitating the implementation of these resolutions or the continued examination of the question."<sup>2</sup>
  - In order to ensure that resolutions have greater political impact, they should be short, in particular as regards the preambular parts, and should focus more on action-oriented operative paragraphs (resolution 57/270 B of 23 June 2003, para. 69).
  - Whenever possible, for the adoption by the General Assembly of agreed texts of resolutions and decisions, informal consultations should be carried out with the widest possible participation of Member States (resolution 45/45, annex, para. 1 (A/520/Rev.15/Amend.1, annex VIII, para.1)).

30. The General Committee took note and decided to bring to the attention of the General Assembly that the Secretary-General encourages Member States to transmit all draft resolutions and decisions in electronic form as well as on paper and that the submitters are responsible for ensuring that the electronic and paper versions of the draft resolutions and decisions are identical in content.

## I. Documentation

31. The General Committee draws the following to the attention of the General Assembly that:

The General Assembly, including its Main Committees, should merely take note of those reports of the Secretary-General or subsidiary organs which do not require a decision by the Assembly and should neither debate nor adopt resolutions on them, unless specifically requested to do so by the Secretary-General or the organ concerned (decision 34/401, para. 28 (A/520/Rev.15, annex VI)).

32. The General Committee also draws the attention of the General Assembly to resolution 57/283 B of 15 April 2003 regarding timely issuance of documents in the six official languages of the General Assembly.

33. The General Committee further draws the attention of the General Assembly to resolutions 48/264 and 55/285, in which the Assembly emphasized that restraint should be exercised in making requests for new reports and requested more

integrated reports, and to resolution 57/270 B, in which it recognized the need to avoid requesting duplicative reports from the Secretary-General.

- 34. The General Committee draws to the attention of the General Assembly that:
  - Resolutions should request observations from States or reports by the Secretary-General insofar as they are likely to facilitate the implementation of the resolutions or the continued examination of the question (resolution 45/45, annex, para. 10 (A/520/Rev.15/Amend.1, annex VIII)).
  - Member States and entities of the United Nations system should make a serious effort to submit their replies and inputs to requests for information or views pursuant to resolutions of the General Assembly within the prescribed deadlines (resolution 55/285, annex, para. 17).

35. The General Committee also draws to the attention of the General Assembly paragraph 6 of the annex to resolution 58/316 concerning documentation.

#### J. Questions relating to the programme budget

36. The General Committee draws the attention of the General Assembly to rule 153 of the rules of procedure, which reads:

"No resolution involving expenditure shall be recommended by a committee for approval by the General Assembly unless it is accompanied by an estimate of expenditures prepared by the Secretary-General. No resolution in respect of which expenditures are anticipated by the Secretary-General shall be voted by the General Assembly until the Administrative and Budgetary Committee (Fifth Committee) has had an opportunity of stating the effect of the proposal upon the budget estimates of the United Nations."

37. The General Committee also draws the attention of the General Assembly to paragraphs 12 and 13 of its decision 34/401 (A/520/Rev.15, annex VI), which read as follows:

"12. It is imperative that Main Committees should allow sufficient time for the preparation of the estimate of expenditures by the Secretariat and for its consideration by the Advisory Committee on Administrative and Budgetary Questions and the Fifth Committee and that they should take this requirement into account when they adopt their programme of work.

"13. Furthermore:

"(a) A mandatory deadline, not later than 1 December, should be established for the submission to the Fifth Committee of all draft resolutions with financial implications;

"(b) The Fifth Committee should, as a general practice, consider accepting without debate the recommendations of the Advisory Committee on Administrative and Budgetary Questions on the financial implications of draft resolutions up to a prescribed limit, namely, \$25,000 on any one item;

"(c) Firm deadlines should be set for the early submission of the reports of subsidiary organs which require consideration by the Fifth Committee;

"(d) A minimum period of forty-eight hours should be allowed between the submission and the voting of a proposal involving expenditure in order to allow the Secretary-General to prepare and present the related statement of administrative and financial implications."

38. The General Committee further draws the attention of the General Assembly to regulation 5.9 of the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation (ST/SGB/2000/8; first adopted in resolution 37/234, annex; most recently amended in section III of resolution 53/207), which reads as follows:

"*Regulation 5.9.* No council, commission or other competent body shall take a decision involving either a change in the programme budget approved by the General Assembly or the possible requirement of expenditure unless it has received and taken account of a report from the Secretary-General on the programme budget implications of the proposal."

39. The General Committee draws the attention of the General Assembly to paragraph 6 of its resolution 35/10 A of 3 November 1980, which reads as follows:

"6. *Decides* that all proposals affecting the schedule of conferences and meetings made at sessions of the General Assembly shall be reviewed by the Committee on Conferences when administrative implications are being considered under the requirements of rule 153 of the rules of procedure of the Assembly."

40. The General Committee also draws the attention of the General Assembly to section VI of its resolution 45/248 B of 21 December 1990 on procedures for administrative and budgetary matters, which states that the Assembly:

"1. *Reaffirms* that the Fifth Committee is the appropriate Main Committee of the General Assembly entrusted with responsibilities for administrative and budgetary matters;

"2. *Reaffirms also* the role of the Advisory Committee on Administrative and Budgetary Questions;

"3. *Expresses its concern* at the tendency of its substantive Committees and other intergovernmental bodies to involve themselves in administrative and budgetary matters;

"4. *Invites* the Secretary-General to provide all intergovernmental bodies with the required information regarding procedures for administrative and budgetary matters."

(See also section III, paras. 43 and 44.)

### K. Observances and commemorative meetings

41. Considering past practice, the General Committee recommends to the General Assembly that it adopt a format for commemorative meetings that includes statements by the President of the General Assembly, the Secretary-General, the chairmen of the five regional groups and the representative of the host country.

### L. Special conferences

42. The General Committee draws the attention of the General Assembly to the following:

- The Committee on Conferences recommended that the General Assembly should instruct the Main Committees to review the number of special conferences of the United Nations already proposed and scheduled in their respective fields of activity prior to deciding upon the scheduling of new and additional special conferences, thus bearing in mind the relevant portions of General Assembly resolution 33/55 (recommendation 6 of the Committee on Conferences,<sup>3</sup> adopted by the Assembly in decision 34/405 of 1 November 1979, para. (b)).
- The decision of the General Assembly that no more than five special conferences should take place in a given year and that no more than one special conference should be convened at the same time should be strictly implemented.<sup>4</sup>
- The existing principle that United Nations bodies should meet at their respective established headquarters, as provided for in General Assembly resolution 40/243 of 18 December 1985, should be strictly enforced. Whenever the Assembly accepts an invitation from the Government of a Member State to hold a conference or meeting away from established headquarters, the additional cost should be borne in full by that Government. The methods of budgeting these costs should be improved so as to ensure that all additional costs are accounted for.<sup>5</sup>

# III. Observations on the organization of the work of the General Assembly

43. With regard to rule 153 of the rules of procedure on the financial implications of resolutions and paragraph 13 (d) of decision 34/401, which requires a minimum period of forty-eight hours before action is taken on a proposal so as to allow the Secretary-General to prepare the programme budget implications of drafts before the General Assembly, the General Committee draws the attention of the Assembly to the fact that, in most cases, more than forty-eight hours are required for the Secretary-General to review the programme budget implications of proposals before the Assembly.

44. The General Committee also draws the attention of the General Assembly to the fact that, in accordance with rule 78 of the rules of procedure, proposals have to be submitted well in advance of their consideration, in order to ensure that copies have been circulated not later than the day preceding the meeting at which they will be considered.

# **IV.** Adoption of the agenda

45. The General Committee considered the draft agenda of the fifty-ninth session submitted by the Secretary-General in his memorandum (A/BUR/59/1). All proposals for the inclusion of items in the agenda of the fifty-ninth session have been communicated to Member States in the following documents:

(a) Report of the Secretary-General (A/58/864, sect. II);

(b) Supplementary list of items proposed for inclusion in the agenda of the fifty-ninth session (A/59/200).

46. The General Committee took note of the relevant resolutions pertaining to the review of the agenda, namely, annex I to resolution 48/264, the annex to resolution 51/241, the annex to resolution 55/285, paragraphs 2 and 4 of annex to resolution 58/316, and paragraph 60 of resolution 57/270 B, in which the General Assembly stated that the General Committee should ensure better coordination of the agendas of the Second and Third Committees.

47. In paragraph 2 (a) of the annex to resolution 58/316, the General Assembly decided, inter alia, that the agenda of the General Assembly should be organized under headings corresponding to the priorities of the Organization, as contained in the medium-term plan for the period 2002-2005 (or in the strategic framework, as appropriate), with an additional heading for "Organizational, administrative and other matters" for the purpose of giving a sense of structure to the work of the Assembly. The headings of the agenda are given in paragraph 2 (b) of the annex to resolution 58/316.

48. In paragraph 4 (b) of the annex to resolution 58/316, the General Assembly decided that the items entitled "Question of Cyprus", "Armed aggression against the Democratic Republic of the Congo", "Question of the Falkland Islands (Malvinas)", "The situation of democracy and human rights in Haiti", "Armed Israeli aggression against the Iraqi nuclear installations and its grave consequences for the established international system concerning the peaceful uses of nuclear energy, the non-proliferation of nuclear weapons and international peace and security", "Consequences of the Iraqi occupation of and aggression against Kuwait" and "Declaration of African Unity on the aerial and naval military attack against the Socialist People's Libyan Arab Jamahiriya by the present United States Administration in April 1986" should remain on the agenda for consideration upon notification by a Member State.

49. In paragraph 4 (d) of the annex to resolution 58/316, the General Assembly decided, inter alia, that, while remaining on the agenda of the plenary, the item entitled "Elimination of unilateral extraterritorial coercive economic measures as a means of political and economic compulsion" should be considered every three years.

50. Bearing in mind the extremely heavy workload of the General Assembly and the need to make the most effective use of scarce resources, the General Committee took note of the suggestion by the Secretary-General to consider deferring to a later session items for which decisions or action were not required at the current session (resolution 51/241, annex, paras. 23-26).

51. The General Committee took note of General Assembly decision 49/426 of 9 December 1994, whereby the Assembly decided that the granting of observer status in the Assembly should in the future be confined to States and to those intergovernmental organizations whose activities covered matters of interest to the Assembly.

52. With regard to item 28 of the draft agenda (Question of the Comorian island of Mayotte), the General Committee decided to recommend that the consideration of the item be deferred to the sixtieth session and that the item be included in the provisional agenda of that session.

53. With regard to item 84 of the draft agenda (Question of the Malagasy islands of Glorieuses, Juan de Nova, Europa and Bassas da India), the General Committee decided to recommend that the consideration of the item be deferred to the sixtieth session and that the item be included in the provisional agenda of that session.

54. With regard to item 152 of the draft agenda (International convention against the reproductive cloning of human beings), the General Committee decided to move the item from heading I to heading F.

55. In connection with item 153 of the draft agenda (Observer status for the Shanghai Cooperation Organization in the General Assembly), the General Committee decided to recommend its inclusion under heading I.

56. With regard to item 154 of the draft agenda (Observer status for the Southern African Development Community in the General Assembly), the General Committee decided to recommend its inclusion under heading I.

57. In connection with item 159 of the draft agenda (Question of the representation of the twenty-three million people of Taiwan in the United Nations), the General Committee decided not to recommend its inclusion.

58. With regard to item 160 of the draft agenda (Observer status for the Collective Security Treaty Organization in the General Assembly), the General Committee decided to recommend its inclusion under heading I.

The General Committee took note of the relevant resolutions and decisions dealing with guidelines for the allocation of items, namely, decision 34/401 (A/520/Rev.15, annex VI), resolution 39/88 B, resolution 45/45 (A/520/Rev.15 and Amend.1, annexes VII and VIII), annex I to resolution 48/264 and the annex to resolution 51/241. 62. The General Committee took note and decided to draw to the attention of the General Assembly that any request by an organization for the granting of observer status in the General Assembly will be considered in plenary meeting after the consideration of the issue by the Sixth Committee of the Assembly (resolution 54/195). (See also paragraph 51.)

63. Taking into account the recommendations in section IV above regarding the adoption of the agenda, the General Committee approved the allocation of items contained in paragraph 74 of the memorandum by the Secretary-General (A/BUR/59/1), with the modifications recommended in paragraphs 64 to 70 below.
