## Citizenship/Immigration Status Verification Form-"Affidavit"

Colorado Revised Statutes section 24-76.5-103 requires all state agencies to verify the lawful presence in the United States of all <u>natural persons</u> (individuals and individuals doing business as sole proprietors) who apply for certain public benefits, including the license, permit or registration for which you are applying. This requirement applies <u>only</u> to natural persons. It does <u>not</u> apply to partnerships, corporations or other business entities that apply for state benefits.

If you are applying for a license, permit or registration for yourself, or for a business for which you are the sole proprietor, you must provide the information requested in numbered paragraphs 1 through 4 on this form, sign and date it, and submit it along with your application form. If, however, you are applying for a license, permit or registration that will be issued to a partnership, corporation or other type of business entity, you do <u>not</u> need to fill out this form or submit it.
