In the event treatment is required from a physician and/or hospital personnel designated by Teenage Christian Camp, I/We agree to hold such person free and harmless of any claims, demands, or suits for damages arising from the giving of such consent. I/We also acknowledge that we will be ultimately responsible for the cost of any medical care should the cost of that medical care not be reimbursed by the health insurance provider or if I/We do not carry any health insurance. Further, I/We affirm that the health insurance information provided, if applicable, is accurate at this date and will, to the best of my/our knowledge, still be in force for the student named above. I/We also agree to bring my/our child home at my/our own expense should he/she become ill or if deemed necessary by Teenage Christian Camp staff members.

We expect ALL CAMPERS and VISITORS to conform to the camp rules as published in the current camp application. These are summarized as follows:

Christ-like attitude at all times

No possession or use of alcohol, drugs, or tobacco

No campers can drive or leave the camp property without pre-approved permission

No campers can ride with any person other than those with pre-approved permission

No fighting, weapons, ammunition, fireworks, lighters, or explosives

No offensive or immodest clothing, including swim wear

No sleeveless shirts -- shorts must be knee-length or longer

No offensive language of any kind -- no put-downs, gossip, or cursing

No public display of affection of any sort

Full participation in all activities with the group is expected, unless excused by camp nurse

Respect property – no destruction of property or wildlife – no pets

Respect one another, staff, and adult leaders

No cameras / devices with cameras allowed in bathhouses or pool

All campers must be in assigned quarters after lights out

Respect and comply with camp rules, dress code, and schedule

Campers who fail to comply with these expectations may be sent home at their parents' expense.
