CLASSICAL IMPROVISATION

BRIAN CHUNG, co-author of Improvisation at the Piano:
A Systematic Approach for the Classically Trained Pianist

SESSION SUMMARY:

Those who wish to explore improvisation are often encouraged to study jazz. But is that really the best way to learn improvisation? Couldn't the classically trained pianist learn to improvise in the classical style? This session is for the *classical* musician. It will explain an enjoyable and systematic approach to improvisation built entirely upon the elements of traditional piano study.

DURING THE SESSION, LEARNING TO IMPROVISE WILL BE COMPARED TO THE PROCESS OF LEARNING TO TALK. TALKING BEGINS WITH THE DESIRE TO SAY SOMETHING PERSONAL AND MEANINGFUL. THIS IS THE HEART OF IMPROVISATION IN ANY FORM. NEXT, THE TALKING PROCESS MOVES FROM THE **PRODUCTION OF SOUNDS TO BUILDING VOCABULARY, APPLYING GRAMMAR AND, EVENTUALLY, COMMUNICATING WITH EASE.**ONE CAN LEARN TO IMPROVISE BY FOLLOWING THIS SAME SERIES OF PROGRESSIVE STEPS USING ONE'S EXISTING SKILLS AS A PIANIST.

Brian Chung has delivered various forms of this seminar at the 2007 MTNA Collaborative Conference (Toronto), World Piano Pedagogy Conference, 2008 MTNA National Conference (Denver), National Conference on Keyboard Pedagogy (Chicago), National Piano Teachers Institute (Dallas) and the 2009 MTNA National Conference (Atlanta).

Brian Chung is Senior Vice President of Kawai America Corporation. He is a two-term president of the Piano Manufacturers Association International, chair of the MTNA Foundation Fund Development Committee, a 2004 MTNA Foundation Fellow, and recipient of the 2010 MTNA Distinguished Service Award. He is also co-author of *Improvisation at the Piano: A Systematic Approach for the Classically Trained Pianist* (Alfred Publishing 2007), co-author of the *Recreational Music Making Handbook for Piano Teachers* (Alfred 2009) and author of *Expressions of Faith: Eight Inventive Explorations of Classic Hymns for Solo Piano* (Alfred 2008).

Convention Registration

Cvent was launched on March 1st. Email invitations were sent to all members. A member who goes to the convention just to listen to his/her student(s) perform at a convention recital, or just to preside at a student recital, or only attend an Evaluator Training or a Branch Treasurer/Membership Secretary meeting or Branch President's Breakfast must register for the convention for the day the student recital or meeting takes place.

Be sure to register on or before May 15 to get the special Early Bird rates. You may pre register until June 15. After June 15, the onsite full registration rates apply.

Hotel Reservation

Go to www.mtac.org/convention or call 1-800-991-7249 to the Oakland Marriott City Center to make your hotel reservation. Reserve on or before June 15, 2011 to receive the MTAC group rate of \$109 per night for single or double occupancy. \$129 for triple. \$139 for quadruple. You must identify yourself as members of the Music Teachers' Association of California 2011 Convention Group to receive the group rate.

Hotel Parking

Self-parking at the connecting Oakland Convention Center garage is \$16 per day per car with no in-and-out privileges. Hotel Valet Parking 6-24 hours is \$28 plus 18.5% tax.

If you are a brand new member in the 2010-2011 fiscal year, you can receive a \$40 discount from your convention registration. Please note this new member discount applies to Early Bird and Pre registration only.

Membership Update

The State Board is announcing a new policy which will now be in effect at the State Office regarding the listing of a Secondary Subject (following a members' name) in our MTAC State Directory. Since the past has allowed for considerable inconsistency in how members requested or applied for a Secondary Subject listing. Please note that this information applies only to Secondary Subjects, and not Secondary Instruments.

Beginning with the 2011-2-12 State Directory listings, the following policy will apply to all Secondary Subject listings:

- 1. The Secondary Subject must be documented by the MTAC member's transcript.
- 2. The Secondary Subject must be approved by the State Board. The preliminary Approved List is as follows:

Collaborative Artistry

Conducting, specific area as applicable

Composition

Improvisation

Jazz Theory

Music Education

Music History

Music Theory

Music Therapy

Musicology, with area of concentration defined

Music Pedagogy, with specific instrument defined

Film Scoring

Others, upon State Board recommendation

- 3. Additional Secondary Subjects may be added at the approval of the State Board, upon request from the applying member.
- 4. To receive approval, a Secondary Subject must be a teachable subject and also a subject by which a degree can be obtained.
- 5. Approval will no longer be given to music programs which cannot be shown on a transcript or which require a licensing or certification process to use.

All Secondary Subjects listed within our 2010-2011 MTAC State Directory which are similar to those on the above list, will be grandfathered and members will not be required to reapply under the new guidelines for their Secondary Subject listing. However, current listings which fall within the scope of #5 above, such as music programs by which the member receives a license or certification rather than a college or university transcript verification, will no longer be listed, beginning with the 2011-2012 MTAC State Directory. Two such examples, among others, are the Kodaly and Kindermusik programs.


