Come and enjoy your Brothers and hit a golf ball or two with them, then enjoy a special dinner put on after the tournament.

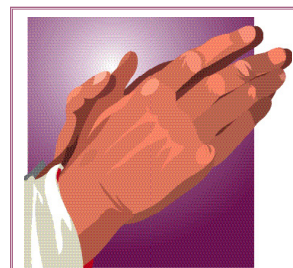
If you like just being with our faith community and want to eat a hot dog or two and even a hamburger, then the summer barbecue will be there for you, so enjoy Easter for now.

He will also certify that the Candidate has signed the gaining Council's Constitutional Role prior to arriving at the Exemplification.


