

Purpose of this form

If your parent or carer previously had a Carer Allowance Health Care Card (under 16) for you, you may be eligible for a Health Care Card if you are a full-time student and are under 26 years of age.

You will need to complete this form to apply for a Carer Allowance Health Care Card in your own name (not in your carer's name).

Australian residence requirements

- you have never claimed a Centrelink income support payment or concession card in the past.

Confirming your identity

You may be required to confirm your identity when claiming a Health Care Card for former recipients of the Carer Allowance Health Care Card (under 16). To confirm your identity, you must provide **original** documents (not copies).
