DESCRIPTION OF INCIDENT:

On July 30, 2015 at 1543 hrs the Kent County Sheriff's Department and Cannon Township Fire Department responded to a one vehicle accident on Sunfish Lake Ave Ne near Belding Road in Northeast Kent County. A Honda Civic driven by a 17 year old Rockford man lost control of his vehicle in the curves and the vehicle rolled. The driver was ejected and suffered serious injuries. He was transported by Aeormed but is expected to survive. Alcohol was not a factor and the investigation is ongoing.
