The combination of items requested and information provided on this petition will be taken into consideration in the review for tuition reclassification. All documentation submitted must be dated to clearly support that the twelve-month waiting period has been satisfied. Your signature certifying that the information provided is true and complete must be officially witnessed by a Notary Public. A Notary Public is available in the KSU Residency Office, 3391 Town Point Drive, Ste 3700.

A person's legal residence is the place where he/she is generally understood to reside with the intent to remain indefinitely and return when absent. There must be a concurrence of actual residence and the intent to remain indefinitely to acquire a legal residence. Oncampus housing does not meet this criterion.

For the purpose of these regulations, legal residence must be established in Georgia for a purpose independent of attendance at an institution of higher education. A student cannot receive more than 40% of their financial support from a parent in another state. The student must be able to provide a GA 500 income tax return showing a minimum of \$11,170 income (Health and Human Services Poverty Guidelines, 2012). If under the age of 24, the student must also provide a copy of the parent's Federal tax return showing that they are not claimed as a dependent. The student cannot be receiving financial aid based on the parent's income. In the event that you are claimed on the tax return of a parent/guardian in a state other than Georgia, you are considered a resident of that state and as such are not eligible to adjust your tuition classification status.

A student's resident status is not changed automatically, and the burden of proof that the student qualifies as a legal resident under the regulations of the Board of Regents of the University System of Georgia rests with the student. A student is responsible for registering under the proper tuition classification.

The petition must be filed no later than 60 days after the semester begins in order for the student to be considered for reclassification for that semester. If the petition is granted, reclassification will not be retroactive to prior semesters.
