**PURPOSE/SUMMARY:**

The Real Estate Division requests legislation be brought before City Council seeking authorization for the Mayor to execute the attached Second Amendment to Lease with the Cultural Council of Greater Jacksonville, Inc. This amendment extends the lease for ten (10) years and establishes a rental rate of \$12.34 per square foot, which is 3% higher than the previous year's rate. The rent is scheduled to escalate annually by 3% during the 10-year term for the 1,864 square feet premises located on the second floor of the Times Union Performing Arts Center Building at 300 West Water Street.
