1. PROSPECTIVE LICENSEE APPLICATION FORM

All prospective licensees must complete the Prospective Licensee Application Form supplied by MLB Advanced Media, LP (“MLBAM”). When completing the form, please be as detailed as possible concerning the following matters:

- Company information and credit references.
- Description of products and samples. If product categories differ greatly, then describe how your distribution would differ for each product category.
- Retail and wholesale Internet/Interactive Media distribution channels (e.g., Internet, wireless devices, Smart cards, Kiosk, etc.) and target consumers.
- Marketing plan for licensed product(s).

2. FINANCIAL REQUIREMENTS

A royalty based on a percentage of “net sales” compensation is paid to MLBAM on the sale of each MLBAM-licensed product. Special programs may have different rates.

Annual minimum guaranteed compensation to MLBAM is payable by licensee upon execution of a standard agreement.

- D. This form and my responses hereto shall not give rise to any binding obligation on the part of either party. MLBAM shall have no obligation to enter into any agreement or relationship with me or my company, and no MLB entity shall have any liability for failure to do so.
- E. Your Company agrees to indemnify, defend and hold harmless all MLB Entities from and against any claim, loss, obligation, liability, or expense including reasonable attorney's fees that may be asserted against or incurred by such Entities in connection with the submission submitted hereunder or any breach of any representation, covenant or warranty made by your Company hereunder, and agrees and covenants: (a) not to challenge any MLB Entity, or sue or commence any action, proceeding, or claim in any judicial, mediation, or arbitration forum ("Sue") against any MLB Entity, in connection with: (i) MLBAM's process for international licensing; and (ii) MLBAM's use/non-use of the submission or any decision by MLBAM or any MLB Entity in respect thereof; and/or (b) not to Sue any individual or entity based on the information provided in response to any inquiry made by any MLB Entity.
- F. The United States District Court for the Southern District of New York and the Supreme Court of the State of New York, sitting in New York County, shall be the exclusive

jurisdictions and venues for any dispute arising directly or indirectly from this form and my responses hereto, and/or the relationship and transactions contemplated and/or created by this Agreement. I consent to the jurisdiction and venue of any such court and waive any argument that any such court does not have jurisdiction hereof or that venue in any such forum is not appropriate or convenient.
