ADDITIONAL SPECIAL INSTRUCTIONS

- 1. The work shall be carried out without disturbing the operation of the Port or other agencies working in the area.
- 2. The tenderer shall also assess and include the cost of material, labour, tools and plants and machinery/equipment for maintenance work that may be required to be carried out by him during the free maintenance period.
- 3. Tenderers are advised to go through the Schedule of Quantities and Rates and sequence of work before submission of the tender. They are also advised to inspect the site, ascertain for themselves the nature and the extent of work involved and also obtain all clarifications they may require before filling in the tender.
- 4. Tenderers are required to sign with date the Schedule of Quantities and Rates and the form of tender and fill in all the particulars and details called for therein. Unsigned tenders, without the details called for are liable for rejection.

5. Measurements

The quantities provided for in the Schedule of Quantities and Rates are only approximate and are given to provide a common basis for tendering. The actual quantity may differ as per site conditions. Payments will be made according to the actual quantities of work ordered and carried out, jointly measured by the representative of Chief Engineer and the contractor.

- **6.** Rates and Prices to be inclusive.
 - The percentage rates stated in the Schedule of Quantities by the contractor shall include the provision of all supporting special equipment, labour of required skill, supervision, materials, erection, overheads and profits, watch and ward, insurance charges, during execution and every incidental and contingent costs and charges, whatsoever, including Income tax, Sales tax on works contracts, VAT, Service tax, etc. if any, for compliance with conditions of contract and specification.
- 8. Time is the essence of contract and the entire works should be completed within a period of One month as specified in the Schedule. The tenderer shall also submit detailed programme for the timely completion of work giving details of gangs/labour/material supply/plant and machinery etc. taking into account the time schedule provided and weather conditions during the period.
- 9. The Tenderer's supervisory staff shall be fully experienced in the type of work to be carried out under their supervision.
- 10. After completion of work the contractor shall clean, clear the work site to the satisfaction of the Chief Engineer or his site representative.
- 11. The material procured for this work, shall be initially approved by the Engineer-In-Charge and the Chief Engineer by producing a sample of the material to be employed in the item of work. All catalogues, specifications may be provided for obtaining the approval of competent authority.

All the materials required for the work a sample of each material has to be presented for approval, with the selected materials such as tiles etc a pattern has to be designed and presented for approval. Both these bids should be submitted in two separate envelopes. Only parties that meet the criteria as specified in the technical bid will be considered and their Price bids will be opened.
 - A) Technical Bid consists of the following main conditions:
 - a) Eligible parties will have to deposit Rs. 16,700/- as Earnest Money Deposit by way of Demand Draft in favour of FA&CAO, MPT along with the Tender documents in Cover No. 1.
