


Notice by Seller

Cancellation for Breach by Buyer

- 🔊 This Cancellation for Breach is a letter that can be used by a seller when the buyer has breached an Agreement for purchasing (usually paying for) your Goods.
- 🔊 Under the Uniform Commercial Code (UCC), a seller of goods may cancel an agreement with a buyer if the buyer wrongfully rejects the goods, revokes an acceptance of the goods, refuses to honor the contract, or fails to make a payment due on or before delivery of the goods.
- 🔊 If one of these events has occurred, the seller may cancel the contract if the buyer's breach substantially impairs the value of the contract to the seller.
- 🔊 Cancellation by the seller terminates the contract and reinstates the title to the goods to the seller. Any remaining obligations of the buyer or seller are discharged, but the seller retains the right to pursue any remedies for  buyer's breach.
