5. **DD214 Form** – **Verification of parent/grandparent military status.**

Scholarship monies will be paid directly to the Post-Secondary Institution upon receipt of Scholarship Recipient Agreement Form, which is completed by the Student. Student must send Recipient form and verification of enrollment by August 1st to CFCC or scholarship monies may be forfeited.
