AGTA GemFair Tucson is open to all qualified professionals who purchase WHOLESALÉ for the purpose of RESALE. A business card, copy of W-2 or copy of pay stub must be provided for each buyer who attends GemFair.

REQUIRED DOCUMENTATION:
(SEND one of the following with registration)

- JBT number.
- Proof of membership in AGTA, AGS, ASA, DCA, ICA, IDCA, ISA, JA, JVC, MJSA, NAJA.
- A letter from an AGTA member indicating you are his/her wholesale client.

IF YOU DO NOT MEET THE ABOVE QUALIFICATIONS FOR ADMISSION YOU MUST PROVIDE ONE OF THE FOLLOWING:

- Copy of your business license or tax-exempt certificate clearly demonstrating industry affiliation.

- Copies of itemized invoices (totaling \$10,000) from three different

suppliers of jewelry, precious metal or colored gemstones for purchases made within the past year. Each invoice must show multiple items.

REGISTRATION GUIDELINES:

Registration forms received after advanced registration deadline, will not be processed and attendees must register onsite with proper documentation.
