Electrical Permits for installation, replacement or repair shall be \$50.00 + 1.75% of the job valuation.			
<i>(State surcharge is .0005 times the job valuation. Call the Inspections Department at (952) 924-2588 for state surcharges on all permits valued at \$1,000,000.00 or more).</i>			
<ul style="list-style-type: none"> • When applicable, a plan review charge equal to 35% of the electrical permit fee will be added. 			
Exceptions:			
Installation, replace or repair of a <u>single</u> electrical appliance or device within a single-family dwelling shall be \$50.00 + 1.00* = \$51.00			
Installation of a new traffic signal <u>per location</u> shall be \$150 + 1.00* = \$151.00			
<i>*State surcharges are calculated at \$1.00 for single item permits issued under this exception</i>
