Junior members have 7 day advanced access to tee times. Public has 7 day advanced access to tee times. Membership is non-refundable, and non-transferable. Customer will be and remain responsible for all authorized credit extended by the issuer. Monthly statements will be electronically filed with your given email address. You have the option of requesting a paper statement to be mailed. If you think there is an issue in your statement, or you need more information about a transaction on your account, you can telephone us at 207-775-6257, or mail a certified letter to General Manager, Attention Disputes, 505 Country Club Drive, South Portland, Maine, 04106. All errors or disputes must be resolved within sixty (60) days of receipt of the statement. We must acknowledge receipt of communication within 30 days, and we cannot try to collect any amount in question, or report you as delinquent until the amount in question is rectified. If you fail to pay the amount that we think you owe, we may report you as delinquent. However, if our explanation does not satisfy you, and you write to us within ten (10) days telling us that you still refuse to pay, we must tell anyone we report you to that you have a question about your statement, and we must tell you the name of anyone we reported you to. We must tell anyone we report you to that the matter has been settled between us when it is.
