Education of clerks statewide is a primary goal of the Alaska Association of Municipal Clerks (AAMC). To assist with this goal, AAMC has applied for grant funding from the Denali Commission to support scholarships for rural Alaska Clerks to attend the Northwest Clerks Institute at the University of Puget Sound in Tacoma, Washington. AAMC is also contributing scholarship funds from our fundraising efforts to assist larger municipalities seeking assistance.

If successful in obtaining the grant, AAMC will be awarding scholarships to rural clerks for airfare, and registration expenses, and possibly room and board expenses, depending on available funds. # ALASKA ASSOCIATION OF MUNICIPAL CLERKS 2010 NORTHWEST CLERKS INSTITUTE SCHOLARSHIP PROGRAM

#### **PURPOSE**

To provide education and encourage professionalism of Alaska Clerks by awarding financial scholarships to qualified applicants, who without assistance would be unable to attend an Institute. Further, completion of the three-year Institute is essential to clerks to receive the designation of Certified Municipal Clerk (CMC) from the International Institute of Municipal Clerks (IIMC) that attests to the professional quality and competency of our Alaskan Clerks.

#### **GUIDELINES**

The following criteria shall be considered by the Institute Scholarship Committee and judged according to the information provided. Applications must be received by 5 p.m. on the application deadline to be considered and are considered within the limitations of scholarship funds available.

Eligib	ility:
	Applicant must be a municipal clerk, deputy clerk, or clerk-treasurer.
	Only one applicant per municipality.
	Certified Municipal Clerks or those who have completed an Institute or have at least 50
	education points that will go toward your certification are not eligible.
	If not a member of AAMC, a complementary one-year membership will be provided.
Appli	cation Must Contain:
	Completed application form that must be received no later than <b>April 9, 2010</b> .
	A brief statement explaining why the scholarship is needed.
	A statement of support from your municipality allowing attendance at the Institute in the
	event the applicant is awarded a scholarship (form enclosed in this mailing).

#### **General Information**:

- The intent of this program is to provide professional training to clerks who might not otherwise have funding or access to certified training courses.
- Scholarships may be awarded to the same applicant up to a maximum of three years; however, new applications must be submitted each year.
- The scholarship will apply towards air transportation using the least expensive airfare available, (i.e. supersaver, coach 21-day advance fare) and early registration fee for the institute.
- The municipality or applicant must pay the cost of the airfare and registration **upfront and only upon notice that grant funds have been awarded**. AAMC will reimburse the municipality or applicant the scholarship amount awarded only when the applicant provides receipts indicating purchase following notice of grant award, certification of participation, and a completed evaluation form to AAMC by **June 25 for PDI & PDII, and June 29 for PDIII.**
- Applications will be evaluated according to an established point system.
- Scholarships will be announced by April 23, 2010 or following notification from the Denali Commission regarding the award of the grant to AAMC.
- In the event of a cancellation, the applicant is requested to notify AAMC by May 1, 2010 so other applicants may be considered.
- The Northwest Clerks Institute will be held in June 2010 at the University of Puget Sound in Tacoma, Washington.
