Jockey RAFAEL BEJARANO came to the office to review his ride in the last race on Saturday in which he angled out to make some running room turning for home. Although the jockey to his outside told him to go, we felt that he could have completed the move more artfully. Warning issued.

08/24/14² INOUIRY/NO CHANGE

Following the running of the tenth race (Pacific Classic), we posted the inquiry sign to examine an incident in which the second place finisher #8 Toast of New York (V. Espinoza) steadied as the winner passed him at the quarter pole. Films revealed that there was always sufficient clearance between the two horses and that the ride, of the second place finisher may have anticipated interference, rather than suffered interference. Therefore, in our unanimous opinion, no change was appropriate.

FILM REVIEW

Jockey COREY NAKATANI came to the office to review his ride in the fifth race on Sunday. Films showed that he finds himself in a tough spot in the stretch with a horse in front of him and a horse on his outside, with no running room. He eased his mount out, making some contact with the horse to his outside (albeit artfully) to make running room. He acknowledged his actions and left with the warning that while this may have been acceptable in years past, it is no longer the standard. Warning.

Jockey KAYLA STRA came to the office to review her ride in the sixth race on August 21, during which several riders were involved in a bumping incident at the head of the stretch. We felt that all contributed to it, and that Ms. Stra specifically, could have backed up a bit more artfully.

08/28/14³ **AGUAYO HEARING**

We held an informal hearing into case number 14DM029 which was a complaint against trainer VERNON AGUAYO for working his horse while it was on the Veterinarian's List for flipping in the paddock the previous day (and was scratched from that race). He claimed that he didn't know how badly the horse had flipped during the races and that had he known, he wouldn't have worked the horse. Mr. Aguayo also stated that he didn't know the horse was on the vet's list even though the horse was a veterinarian scratch. The rules preclude working a horse 72 hours after being placed on the list. Decision to follow.

Both parties were witnesses and explained from their perspective what happened and what was said. Both accused the other of swearing and being generally abusive. The record was closed and a decision will be made in the near future.

DMTD Ruling #046

Trainer MIKE PENDER, who started the horse "TAKEIT TOTHE LIMIT", sixth place finisher in the sixth race at Santa Anita Park on June 15, 2014, is suspended twenty one (21) calendar days (September 22, 2014 thru October 12, 2014), and fined FIVE THOUSAND DOLLARS (\$5,000.00)*, pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843(a)(d) (Medication, Drugs and Other Substances-methocarbamol, Class 4 - fifth offense in one year). It is recommended that should any of Mr. PENDER'S runners or workers violate a medication positive rule contained in California Horse Racing Board rules 1843,1844 or 1866 within the next 365 calendar days, his license be suspended for a period of not less than six months. Furthermore, Mr. PENDER is prohibited from entering horses while under suspension. During the term of suspension, all licenses and license privileges of Mike Pender are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Pender is denied access to all premises in this jurisdiction.
