## ABOUT CLARE M. HANUSZ:

Clare M. Hanusz is Of Counsel at Damon Key where she specializes her practice in Immigration law. She started her career at Na Loio (now the Hawaii Immigrant Justice Center at Legal Aid) after law school heading up a Neighbor Island immigration project to bring legal services to immigrants in rural and isolated communities.

Since then Clare has represented hundreds of individuals before the immigration court, the Board of Immigration Appeals, the Ninth Circuit Court of Appeals and U.S. Citizenship and Immigration Services. She has assisted clients with naturalization, adjustment of status, U visas (for immigrant victims of certain serious crimes) and T visas for victims of human trafficking, as well as consular processing, waivers of inadmissibility, asylum, special immigrant juvenile status, religious worker visas and options for immigrant survivors of domestic violence.

Clare is the current Hawaii Chapter Chair of the American Immigration Lawyers Association (AILA), and has been active with various advocacy groups and association to address immigration issues. She is a veteran speaker on the topic having spoken on immigration issues before many local groups and university classes.
