3. Select the APPE block during which you would like to complete your CVS elective. Random assignment by the computer is not an option.

5. OEP will submit all CVS special requests to the CVS intern program coordinator on November 16, 2015.
6. You will be notified by OEP when your assignment is confirmed by CVS. In some cases this may not be done until after the APPE schedule is created. Your CVS special request will be blocked of on your schedule even if no assignment has been confirmed.
