CHILD ARRANGEMENTS PROGRAMME (CAP)

A series of CAP standard orders have been prepared as part of the Ministry of Justice's plan to assist families to achieve a swift resolution of a dispute, keeping the children involved at the forefront of proceedings. The process is also expected to be cheaper and quicker.

Although there have been templates issued by the Family Division, we understand that there have been difficulties with their use and HMCTS with a judicial working party are to produce new templates. Once final working versions are available, they will be included in Laserform; we cannot currently give a timescale.
