Bill Gates finds duplicate bridge a "window" to fun

Bill Gates is accustomed to taking on software competitors, government anti-trust lawyers and federal judges, but this weekend he's facing some *really* tough opposition.

Rumors of the Microsoft chairman's attendance at the Anaheim NABC have been circulating all week. Those rumors proved to be true, as Gates entered the Mixed Board-a-Match Teams Saturday with partner Sharon Osberg of San Francisco and teammates Sheri Weinstock of Toronto and Howard Weinstein of Chicago.

Gates has been much in the news of late, with Microsoft battling an anti-trust suit in the federal courts that threatens the software giant with possible partitioning.

With regards to Gates, however, many bridge players have paid less attention to his legal troubles and more to the fact that he has recently been spotted playing at several ACBL-sanctioned events. Although this is the first North American Bridge Championship that Gates has attended, online enthusiasts have known for some time that Gates can frequently be found playing bridge on OKbridge or at The Zone, his own online game site.

Gates frequently plays with partner Osberg, as well as Berkshire Hathaway CEO Warren Buffett and bridge software designer and Bridge Base founder Fred Gitelman. Indeed, Buffett was also scheduled to play

as part of the Gates team in Anaheim, but is recovering from surgery and was unable to attend. Gitelman, too, was supposed to be part of the team but wasn't available to play since he is still doing battle in the Spingold Knockouts as a member of the squad captained by Roy Welland.

It is no secret that players and ACBL officials alike are delighted with Gates' participation in the game. His presence attracts media attention to bridge, and as with any celebrity, provides an opportunity for the game to be showcased to the general public.

In an interview preceding the first qualifying session, Gates appeared excited to be attending his first national event. He and Osberg were engaged in the typical, last-minute fine-tuning of agreements. Gates sought clarification from Osberg on a series of points:

"How likely are we to encounter big club systems, and what defense do we play against them?" or "How do we treat a Precision one diamond opener?", and so on. Osberg reminded him of their methods each time.

Gates and Osberg play fairly straightforward methods.

"We don't play two-over-one," said Gates. "It's pretty much standard Yellow Card."

Gates took time out from the convention card

Caddy champs really know how to play

The caddy champions are a brother act — Marc Glickman, 17, and Robert Glickman, 14, were the victors in the special caddy championship game Friday night. Clearly the brothers know something about the game. As of Friday night, Marc had won 60 masterpoints at this NABC, and Robert wasn't far behind with 35.

Marc has been playing bridge since he was 14, but he didn't try duplicate until this year. The game really turns him on. He's had some outstanding games here — second overall in a Flight B Swiss, second in the Flight A Charity Pairs, and second in one of the knockout events. He came close to winning the knockout — the teams were tied at the end of regulation but Marc lost in the four-board play-off. Marc also went to the ACBL Bridge Camp.

Robert would have loved to go to the bridge camp, but he couldn't — too young. He too has been playing for about three years, but he too also has just started duplicate. In the knockout event where Marc was second, Robert was tied for third — he lost to his brother in a semifinal. He also has a first in a board-a-match game.

The boys have an avid fan — Jim, their father. He has managed to instill his love of the game in his sons.

Welland, Meltzer square off in Spingold final

Teams captained by Roy Welland and Rose Meltzer triumphed yesterday in semifinal Spingold action to advance to today's championship round.

The Welland squad (Brad Moss, Marc Jacobus, Fred Gitelman, Magnus Lindkvist and Peter Fredin) defeated the team of George Jacobs, Ralph Katz, Alfredo Versace, Lorenzo Lauria, Giorgio Duboin and Norberto Bocchi, 151-138.

After a close first quarter, Welland had a large second set to lead at the half, 88-50. The Jacobs team narrowly won the third quarter 33-30, and mounted a rally in the fourth quarter — winning it 55-33 — but fell short of closing the gap by 13 IMPs.

In the other bracket, Meltzer's team (Peter Weichsel, Alan Sontag, Chip Martel, Lew Stansby, and Kyle Larsen) suffered a disastrous first quarter against the squad led by Steve Robinson (Peter Boyd, Kit Woolsey and Fred Stewart), but rallied late in the second half to win 128-115.

Robinson jumped out to a 57-9 lead, which increased slightly by half time when the score was 87-36.

A Losing Option

In the closing minutes of Friday's close quarterfinal Spingold match between Rita Shugart and Rose Meltzer, this little gem came along. It could only have happened against a top expert like Alan Sontag.

After a mildly competitive auction Alan Sontag, by virtue of his earlier Stayman bid, became declarer in 3♣. Andrew Robson led the ♣9 and Sontag won and drew a second trump, Robson pitching a diamond. Sontag then led a diamond from dummy and Shugart rose with the king to play a third trump, Robson pitching another diamond. When Sontag drew the last trump, pitching the ♦Q from his own hand, Robson had an answer — not an obvious one, but one which had a chance to succeed only against one of the world's great players.

Robson could see that Sontag would have no alternative to taking the spade finesse for his ninth trick and that it was destined to win, with the queen-third sitting as it was in front of the king-jack-third. If only there was something he could do to tip the odds slightly in his favor and away from the winning line. Suddenly he found the answer. On the fourth trump Robson discarded — the ♠7!

Just consider the possibility this opened up for Sontag. If North started with ♠1097, South's queen could now be captured by leading the ♠J from dummy and letting it ride if Shugart ducked. If Shugart covered, Sontag would win with the ace, Robson's 9 (or 10) falling, and a second spade to the king would bring down Robson's other intermediate, setting up Sontag's 8.

Sure enough, Sontag worked this out and led the ♠J from dummy (he could have led the ♠K first and Robson would have followed with the 9). When Shugart played low Sontag let it ride and Robson won his queen. He then cashed a second diamond and the defense eventually came to two heart tricks to add to the two diamonds and one spade they had already scored for down one, minus 100.

At the other table Chip Martel and Lew Stansby reached 3♦ on the North-South cards. When this failed by one trick (-100), Shugart picked up five nifty IMPs.

Meltzer won the match 124-119, the margin of victory being — you guessed it — 5 IMPs! If only Robson had had one more opportunity like this one.

New Gold Life Master

Karen McCallum and Kerri Sanborn executed a neat squeeze on declarer on this hand from the Wagar Women's Knockout Teams quarterfinals.

Sanborn started with the ♠Q, ducked. She shifted to a club that ran to declarer's 9. When declarer led the ♥Q, the ducking continued. McCallum ducked the ♥J as well. Now declarer led a diamond, and once again McCallum ducked. Declarer ran the clubs, pitching a diamond from her hand on the last club. This was the position at this point:

Declarer called for a diamond and McCallum was ready. She rose with the ace and immediately put the ♥A on the table. West was helpless. If she pitched a diamond, McCallum's jack was good. If she tossed a spade, Sanborn could run the suit. Down one on a declarer squeeze.

Count, count, count

Geoff Hampson took advantage of all the clues as declarer on this deal from the second round of the Spingold. He was playing with partner Eric Greco.

West led the ♥2, which shows attitude in their methods. The jack was played from dummy and East played the ♥3. East-West were using upside-down count, so this showed an even number. Hampson allowed dummy to hold the trick, and placed West with five hearts, East with four.

Since his 2♦ response to the Stayman inquiry denied a four-card major, Hampson knew that the opponents were aware that the heart suit was running. To make the contract, Hampson needed to run the clubs without a loser. Before tackling the critical suit, however, he played on the other suits to get a count of the hand.

He called the ♦9 from dummy and East covered with the ♦10. Hampson rose with the ace, and West played the queen. The defenders' cards on this trick suggested that East started with K(or Q)-10-8-x-x, and West with either K-Q or Q-J. Next, Hampson played a low spade to the king and another spade to the ace. The opponents knew that Hampson was digging about for clues, so they both gave false count.

"They both showed an even number," said Hampson, "so I played the suit to be 3-3."

The inferential count on the hand, therefore, was 3-5-2-3 for West and 3-4-5-1 for East. So Hampson cashed the ♣A and finessed West for the ♣Q to score up the game.



Allan Siebert earns 20,000th masterpoint

Little Rock businessman Allan Siebert crossed the 20,000 masterpoint plateau here in Anaheim. There are now 30 ACBL members with more than 20,000 masterpoints.

Siebert won the Life Master Pairs in 1995 playing with Joe Kivel, and was second in the event in 1985. Siebert also won the North American Swiss Teams in 1988 with teammates John Zilic, Sylvia Summers, Paul Munafo and brother David Siebert. (David currently has some 19,000 masterpoints.)

Siebert has recorded more than 350 regional wins.

Neat declarer play

Chris Willenken, 24, and Aaron Silverstein, 33, can play well even when they're playing fast – that's why they were victors in the NABC+ Fast Pairs. Here's some neat declarer play by Willenken in the first final session.

South led a spade to the jack and Willenken ducked. He won the trump switch and cashed three rounds, just in case the suit broke 3-3. Perhaps he would have been better advised to give up a trump immediately to gain the tempo. However, this was a matchpoint event, and that play would be costly if the suit broke.

When hearts failed to split evenly, Willenken went after clubs. South made it easy by ruffing the second club. Willenken was able win the spade return, go to dummy with a club to ruff a club, then get back to dummy with the ♦A. Then he pitched his losing spade on the good club and claimed.

But Willenken, who expected South to wait for the third round of clubs before ruffing, was ready for that eventuality as well. South no doubt would have switched to diamonds, and Willenken said he would finesse, losing to the king. North would no doubt switch back to spades, but Willenken would win with the ace. He would then cash his last two trumps. He would have to pitch dummy's last club on the last heart, but North would have to hold the high spade and a diamond while South would hold two diamonds. The distribution of course would be clear at this point – Willenken would know that South started with five diamonds and North with two. So he would finesse in diamonds for the last two tricks.

Safety play pays off

How do you play Q-10-5-3 opposite K-7-6-2 for no more than two losers? You're in a good game, and you cannot afford to lose three tricks in this suit. That's the problem that faced the declarers who played this deal in the final session of the Senior Swiss Teams. Hamish Bennett of the victorious team knew the answer. This was the full deal:

Bennett won the opening heart lead and drew three rounds of trumps, carefully finishing in dummy. Most of the declarers wound up in hand and led a diamond to the king, winning. But now the A-J-9 was over the Q-10-5, so those declarers all lost three tricks and went down one because there was no way to avoid a club loser.

Bennett led a diamond from dummy and put up the queen, losing to the ace – but he noticed that South followed with the 8. He won the heart return and led a second diamond to the 10, losing to the jack. Now he was in fine shape – dummy had the king-7 over North's 9-4, and a simple finesse got him the two diamonds he needed to score his game.

This safety play works whenever South's singleton is anything but the 4. If North held the top four outstanding diamonds, there would be no way to avoid three diamond losers. The safety play also works if South rather than North holds the four diamonds. After leading to the queen, which wins, you return to dummy and lead another diamond and put up the 10. If this loses to the jack, this means the suit broke 3-2 and you have only two losers. And if South has both the ace and the jack, the 10 will win declarer's second diamond trick.

Plus 1050, lose 14 IMPs!

Steve Robinson reported the following pair of auctions from an early round of the Spingold Knock-outs.

As South, both vulnerable, you hold:
♠6 ♥A K 9 8 7 6 4 2 ♦--- ♣K Q 10 4.

You decide to take this hand slowly, and so you open the bidding with 1♥. Left-hand opponent doubles and partner raises to 2♥. RHO bids 2♠ and, anticipating lots more bidding, you try a calm 3♥. LHO jumps to 4♣ which is passed back to you, so you now bid 5♥. LHO doubles, ending the auction. Partner (North) tables:

♠A 7 5 4 3 ♥10 5 3 ♦9 8 5 3 ♣7 3.

Trumps are 1-1, so making six is easy. Plus 1050. Won't this be a great score to take back to your partners? Not necessarily, since this was the auction at the other table:

Canadian bidding

If you want to know how to defend against a Canadian Slam, ask Mike Passell (or check a Daily Bulletin from a few years ago. That old article said something like, "Cash your aces and kings, lead over to partner's ace and king, and then wait for your trump tricks.")

But this is about Canadian Bidding. For instance, we have the auction 1♥-2♥-3♥, ostensibly a game try. Actually it's a transfer sequence – "Whatever happens now is your fault, Pard." The is so because a Canadian Game Try would be

1♥-2♥-4♥.

The following hand came up when I was playing with double Richmond Trophy winner Ken Gee, who is currently leading the Canadian masterpoint race again this year.

I opened 1♦ as South and it went double by LHO, 1♠ by Ken, 2♥ by RHO. Now picturing heart shortness in Ken's hand and hoping for a few diamonds and some useful stuff, I made a Canadian Slam Try – STOP! Six diamonds!

After doubling, LHO led the ♠A. I thought about different options and saw a good chance on the bidding – diamond to West's ace, spade ruffed, diamond to dummy's jack, heart finesse and a heart ruff, spade ruff. Now I could claim on a double squeeze and claim plus 1090.

I even won a bet on the hand since Texas expert George Pisk said the opponents had misdefended. I knew what he meant because repeated club leads kill the double squeeze. But I told George "Redouble!" since I could have ruffed two hearts in dummy since LHO had the stiff ♦A.

Defenses to 1NT

At this NABC, in General Convention Chart events, the Board of Directors has voted to allow constructive defenses to 1NT openings, even when those defenses do not contain a known suit.

Since these are Mid-Chart conventions, it is the responsibility of the pair playing these methods to pre-Alert the opponents and to provide a suggested defense.

In order to help players counter these methods successfully, the tournament is making available copies of an article on the subject, written by Marinesa Letizia, that appeared previously in the ACBL *Bridge Bulletin*. Look for "Counter-Defense to Interference vs. 1NT Opener" in the rooms where General Convention Chart events are played.

discussion to explain his attraction to bridge.

"The game is so deep. There's always something you can learn, and it rewards you when you use good judgment," said Gates, who added, "and it's fun."

Gates said that he reads bridge books and uses instructional software to help him improve his game.

"The software that Fred (Gitelman) has produced is first-rate, and I also really enjoy material by Larry Cohen and Mike Lawrence," said Gates.

The Gates squad had a strong first qualifying session, posting a score of 16 (average was 13), but the foursome had a tougher time of it in the second set, scoring 11 for a total score of 27. This was just enough to qualify, however, as the cutoff score for the final was 26.5.

Gates looked pleased but relieved at the end of the qualifying sessions.

"I knew the second half wasn't as good. We had several bidding misunderstandings that were primarily my fault," he said, laughing.

"I'm not so concerned with bidding mistakes though, because I know that with enough experience, certain types of auctions will start to become automatic. But it's really frustrating to get a play problem wrong. I feel I should always be able to work it out."

Bill Gates finds key to defense

Microsoft boss Bill Gates found the key play to defeat 3♥, and that was good enough to win the board in the first qualifying session of the Mixed Teams.

Despite his lack of high cards, Gates unashamedly bid to the three level, fortified by the knowledge that his partner, Sharon Osberg, had at least two hearts for her opening 1NT. He led a heart and Osberg took two heart tricks before switching to a club. Declarer Steve Landen, ducked this and Gates won the king. It looks reasonable to return a club, but Gates didn't like the looks of that. Instead he switched to diamonds, and suddenly declarer had no way to make the hand. He knew where all the high cards were – Osberg had to have them all for her opening notrump. So Landen knew the finesses in both black suits would work, setting up an endplay. His problem was that he had only one entry to dummy – he knew the diamond finesse would fail – so he could take only one of the finesses. So declarer had to go down one, losing a diamond, two hearts, a club and another black trick.

If Gates had returned a club to the queen and ace at trick three, Landen could cross to the ♦K and finesse in spades. After cashing the ♠A and the ♣J, Landen could lead a third spade to North's king, endplaying Osberg. She would have to lead away from the ♦Q or give a ruff-sluff by leading a club or a heart.

Cinderella Welland will barely escape the pumpkin patch

After going a woeful, pathetic, pitiful 0-2 in the Spingold semifinals, the Bull was feeling his oats late Saturday night at the Cafe Del Sol. Grazing through his plate of vegetarian grains (the Bull hates diets worse than Zero Tolerance), the Bull ruminated over the action from the day's semifinal matches: Kudos first to a valiant loser as Robinson-Boyd and Woolsey-Stewart were shot down by Captain Meltzer-Larsen, Sontag-Weichsel, and Stansby-Martel. Robinson *aka* the Bi-Coastal Little People, jumped out to a 48-IMP first-quarter lead, but a terrible last quarter led to a tough defeat.

On the other side of the bracket Cinderella Welland pulled off its third straight upset, unseating the world-class Italians and giving Jacobs-Katz, Versace-Lauria and Bocci-Duboin an extra travel day before they compete for their respective national teams at the World Team Olympiad in Maastricht next weekend. Welland richly deserves this final – his team came through a tougher bracket than Meltzer by beating the reigning Bermuda Bowl Champion Nickell, the stalwart Schwartz, and powerful Jacobs to win an invitation to Cinderella's Ball.

The 2000 Spingold has driven home the soundness of the ACBL's decision of the early '90's not to prohibit foreign players from entering the Reisinger, Vanderbilt and Spingold. The Bull gives a 21-Longhorn Salute to the incomparable field of the 2000 Spingold. All the brightest stars were out featuring brilliant British, Canadian, Italian, Norwegian, Polish, Swedish, and last, but not least, American constellations. This year's field was the strongest in the history of the Spingold, truly a brilliant performance by both Meltzer and Welland. In the end, American players profit from the tough field by raising their level of play.

On to the finals of the 2000 Spingold:

Original #17, now #1 Cinderella Welland versus original #7, now #2 the Anaheim Rose. Welland, led by Roy, a New Yorker, who is suddenly as strong as his New York IMP game is partnered by Vegas Poker hound Marc Jacobus, with a team also featuring the World Open Pair Bronze Swedish stars Magnus Lindkvist and Peter Fredin and rounded out by the hottest young Can-Am stars, Fred Gitelman and Brad Moss. It is a particularly enjoyable final for Gitelman who plays for the first time on his own vugraph software. As to the Rose Meltzer sextet, Sontag-Weichsel won the 1999 Vanderbilt to restore luster to a partnership begun during the Vietnam War, while Chip Martel and Lew Stansby have won multiple world championships as a pair and survived their own Vietnam War. Finally, Captain Rose and that old crazy, but now calm, Kyle Larsen have raised their level of play to that of the rest of the game.

Who would have guessed this final instead of a Nickell-Jacobs affair? Watch the quarter pole -- Meltzer needs a lead of 20 by the half. If not, the Meltzer energy wears out, "pop pop, fizz fizz", it's an "Alka-Meltzer Day". Youth takes over as Gitelman-Moss and the Swedish Swizzle Sticks get hot in the second half. Book your tickets for the ball -- Cinderella Welland makes it to the goal line just prior to the stroke of midnight, barely escaping the pumpkin patch.
