

GUBERNATORIAL APPOINTMENTS RESUME

Each Board and commission has people serving staggered terms. Appointments are made to most boards and commissions each year. Appointments that require Senate confirmation are made by March 15. Appointments that do not require Senate confirmation are made later, generally by June 15. In order to have the greatest representation possible, all boards and commissions are balanced according to gender and political affiliation. Consideration to geographical location and diversity is also given. Our goal is to attract candidates who will work hard and be responsive to Iowans. This form will assist the Governor and the staff in evaluating the qualifications of an applicant for an appointment to a board or commission. All applications are kept on file as public information and will remain active during the Governor's entire administration.
