Entries	Entries must be submitted no later than Tuesday 21th April 2015 at 23.59 BWF HQ time (GMT +08.00). Players can't be entered unless they already have a BWF ID-number. In case you wish to enter players who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can get a BWF ID-number before the closing date of the tournament. Any player not showing up at the tournament, without having been withdrawn in advance, renders the Member Association concerned liable to an additional amount of US\$ 500,00 for the inconvenience caused by the "no show" (as defined in BWF General Competition Regulations). According wth BE Circuit Regulations 3.3. It is required that every event in a particular BE Circuit tournament has at least 8 competitors (i.e. actual competitors, not merely entries). If the required number of competitors is not met, this particular event shall not count towards any ranking. In accordance with regulation 10.5 in Appendix 6 to BWF's General Competition Regulations, an event must contain at least one entry from a Member Association other than the hosting Association. If an event does not contain at least one entry from a Member Association other than the hosting Association, this particular event shall not count towards any ranking. BADMINTON EUROPE is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.
