Personal Invitation. If visiting friends or family, you must provide letter of invitation with the contact information of the host and visitor, purpose and duration of the visit, confirmation of accommodation including the address, signature and date. You will also need to
provide proof of the host's status in Nigeria ie. copy of their Nigeria passport's information page, or, if they are not a citizen of Nigeria,
copies of their Nigeria residence permit and their national passport's information pages.
Host passport. Scanned copies of the passports of the hosts you are visiting in Nigeria
Previous visa. If applying for a multiple entry visa , please provide a copy of a previous Nigeria visa and a copy of the information pages of the passport containing the visa. The embassy will not grant a multiple entry visa to a first-time visitor.
Additional required documents for minors
• Letter of Consent. A letter of consent signed by both parrents.
Birth Certificate. A copy of the applicant's birth certificate.
• Parents' Passport Copies. A copy of the information pages of both parents' signed passports.
