The minutes of the previous meeting dated		2004 were read and approved by all

The following points as per the scheduled agenda were discussed and decided upon.

Previous Month's Financial Report:

The Secretary informed the members that an amount of Rs 40/- Cash, was in hand on 01 June Savings of Rs. 280/- and extraordinary contribution of Rs. 100/- was received. The Secretary also informed the members that Christina gave her savings after the amount was deposited in the bank and Lydia and Sebrina did not give their savings for the month. The Secretary also said that Rs. 20/- was spent for travel and Rs. 15/- for stationery. She informed the members that the Cash in hand as at 30 June was Rs. 425/-.

Loans Sanctioned:

The Secretary informed the members that the following loan applications were received from six members: Lydia Rs. 2,000/- for a shop; Sebrina Rs. 1,500/- for piggery; Beena Rs. 3,500/- for weaving; Sona Rs. 2,500/- for a shop; Rosyln Rs. 1,000/- for a weaving unit and Sophia Rs. 2,000/- for vegetable garden.

The Secretary also informed the members that Lydia and Sebrina were defaulters in savings and Sona and Rosyln were irregular in their attendance at meetings. After a discussion based on the criteria for sanctioning loans the members unanimously decided to grant loans only to Beena and Sophia. All the members exhorted Lydia and Sebrina to give their savings regularly and Sona and Rosyln to attend meetings regularly for the better performance and growth of the group.

One Day Capacity Building Programme for Members:

The Secretary informed the members that Gana Chetana Samaj planned to conduct one day training programmes for all SHG members in their respective groups and had asked the group to choose any convenient date from 15 September to 30 October 2004. After much discussion on various alternative dates and places for the training programme, the group unanimously decided to have the One Day Training Programme on 25 September 2004, at 10.00 a.m. at Lydia's residence. The members also unanimously decided to collect an amount of Rs. 10/- as extraordinary contribution form each member for refreshments.

Election of New President and Secretary:
