## Homeowners Have a Beef with BofA

Bank of America under-reports to the IRS its customers' tax-deductible "deferred interest" mortgage payments by "millions, if not billions, of dollars," to decrease its reportable income, homebuyers say in a federal class action. Named plaintiff Richard Horn claims Bank of America's intentional misrepresentation prevents borrowers from filing correct tax returns and getting the deductions they deserve. Horn says he is "one of millions of consumers" who were hurt "by BOA's wrongful accounting practices."

Horn, whose mortgage loan is serviced by Bank of America, says he received inaccurate tax forms from the bank which, under-reported the mortgage interest he paid in 2009, 2010 and 2011 by more than \$23,000.

Horn says his adjustable rate mortgage loan (ARM), one of millions of such loans serviced by Bank of America, allows him to make minimum monthly mortgage payments and defer some of the interest due on the note, which is added to the loan balance.

"The issue presented in this action arises when the 'deferred interest' is paid by the consumer, and how BOA then characterizes those payments," the complaint states. "Unlike other national banks, BOA is not treating the consumers' payments of the 'deferred interest' or 'unpaid interest' as mortgage interest at all. Rather BOA mischaracterizes these payments as a 'reduction of principal.' As a result, BOA knowingly and deliberately fails to report the consumers' payment of 'deferred interest' as a payment of 'mortgage interest' on the consumer's IRS Form 1098 BOA files with the IRS."

Horn says Bank of America owns or services millions of adjustable rate loans which are worth billions of dollars.

The bank took over most of those loans from other lenders, such as Countrywide Financial, which BofA acquired for \$4.1 billion in 2008, according to the complaint.

Horn says the bank makes a distinction between principal and deferred interest on its monthly loan statements, but still treats the deferred interest payments it receives as "a reduction in principal."

He says he and other borrowers relied on the bank's tax forms and did not deduct from their taxes the full amount of mortgage interest they paid to BofA.

"Having first realized the under-reporting of mortgage interest by BOA in March 2012, plaintiff contacted BOA about the discrepancy in 'mortgage interest' payments on the IRS Form 1098 issued to him by BOA," the complaint states. "BOA informed plaintiff that the \$10,628 [2011] 'deferred interest' payments were a 'reduction in principal' and therefore not reportable on IRS Form 1098 as 'mortgage interest.' Plaintiff disagreed with this characterization and requested a corrected IRS Form 1098. BOA refused.

"As a result of BOA's mischaracterization of deferred interest payments as principal reduction payments, plaintiff is informed and believes, and thereon alleges that class members are and were similarly affected by BOA's under-reporting of mortgage interest and are and were deprived of the ability to adequately prepare their tax forms and deduct from their taxes the full amount of mortgage interest they paid to BOA in 2011."

Horn claims the bank filed hundreds of thousands, if not millions of inaccurate tax forms, which under-reported borrowers' mortgage interest payments.

He claims the bank "has engaged in this wrongful accounting practice solely to benefit itself by reducing its public debt exposure and to avoid reporting interest income and payment of income taxes on such earned income."

He says other mortgage lenders with similar loans do report the receipt of all mortgage interest paid to them.

Horn seeks class certification, compensatory and punitive damages for breach of contract, negligence, negligent and intentional misrepresentation and unfair business practices, and wants the bank to issue corrected tax forms for the years for which it failed to report all interest payments.

## BP Fines Mount to \$84 Million at Texas City

BP will pay the United States another \$13 million for safety violations at its Texas City refinery that exploded and killed 15 workers, OSHA said Thursday, bringing to \$84 million the total fines issued to that plant.

The fines stem from the March 2005 explosion at the refinery, the Occupational Safety and Health Administration said in a statement.

OSHA fined BP \$21 million in September 2005 and BP agreed to identify and fix deficiencies at the refinery.

During OSHA's follow-up investigation in 2009, it found BP had improved but had not corrected several problems, leading OSHA to issue 270 failure-to-abate notices, the agency said. OSHA also cited BP for 439 willful violations of its process safety management standard that year, including "failing to follow industry-accepted engineering practices for pressure relief safety systems," OSHA said.

BP agreed to pay a \$50.6 million penalty in 2010 to resolve the failure-to-abate notices, OSHA said.

"Under today's agreement, all violations covered in this settlement have been corrected or will be corrected by Dec. 31, 2012, using the procedures established under the 2010 agreement," OSHA said. "Under the 2010 agreement with OSHA, independent third-party experts provided oversight of BP processes for relief and safety instrumented system evaluation, as well as quarterly progress reports on BP's activity.

"The 2010 agreement also required BP to hire independent experts to monitor BP's efforts and obligated the company to allocate \$500 million to ensure safety at the Texas City refinery. "Of the 439 October 2009 willful citations, all but 30 are settled by this agreement."

OSHA said the 30 unresolved citations involve "BP's failure to protect certain pressure relief valves."

## Feds Sue Pot Shop Featured on 'Weed Wars'

The federal government began civil forfeiture proceedings against a medical marijuana dispensary recently featured on a television show.

The United States Attorneys office accused Harborside Health Center in [San Jose](#) and [Oakland](#) of running establishments that sell marijuana in violation of the Controlled Substances Act.

While medical marijuana is legal in California it is still illegal under federal law.

Harborside Health Center became famous nationwide when it was featured on the Discovery Channel show "Weed Wars." According to the lawsuits, it claims to be the largest retailer of marijuana on the planet, serving more than 100,000 customers.

The recent crackdown on medical marijuana dispensaries in California had focused on dispensaries that were allegedly close to schools, parks and playgrounds.

In a press release U.S. Attorney Melinda Haag justified the new approach by explaining, "I now find the need to consider actions regarding marijuana superstores such as Harborside. The larger the operation, the greater the likelihood that there will be abuse of the state's medical marijuana laws, and marijuana in the hands of individuals who do not have a demonstrated medical need."

In the two complaints filed against the separate locations Haag does not accuse the properties of selling marijuana to customers who are not medical marijuana patients or allowing non-patients to obtain marijuana.

Rather the complaint states: "Title 21, United States Code, Section 856 makes it unlawful to rent, lease, profit from or make available for use, with or without compensation, a place for the purpose of unlawfully manufacturing, storing, distributing, or using a controlled substance, to wit: marijuana. Title 21, United States Code, Section 881(a)(7) provides for the forfeiture of all real property, including any right, title, and interest, including but not limited to any ownership, lien holder, or leasehold interest, which is used or intended to be used, in any manner or part to commit, or facilitate the commission of any violation of Title 21, United States Code, Chapter 13, Subchapter 1, to include sections 841 and 856. In light of the foregoing, plaintiff alleges that the defendant real property is subject to forfeiture, pursuant to Title 21, United States Code, Section 881(a)(7), as property which was used or intended to be used, to commit or facilitate the commission of the distribution, cultivation and possession with the intent to distribute and cultivate marijuana."

Jack Gillund, spokesman for the U.S. Attorney's Office in the Northern District of California, informed Courthouse News that "other than the statement we issued yesterday, we have no comment." Courthouse News had asked Gillund if the office wanted to comment on whether it had proof Harborside allowed medical marijuana to get into the hands of non-patients.

In a prepared statement listed on the website for Americans for Safe Access, Harborside Executive Director Steve Angelo stated that "Harborside has nothing to be ashamed of. We will contest the DOJ action openly and in public, and through all legal means at our disposal. We look forward to our day in court, and are confident that justice is on our side."

Harborside maintains that it has complied with all local and state laws and that it was not within 1,000 feet of a school, another rationale the Justice Department is using to target dispensaries even though state law is set at 600 feet, according to the ASA website.

More than 400 dispensaries have shuttered in California since the U.S. Attorneys announced a crackdown against medical marijuana dispensaries in October 2011, "mostly from the specter of federal criminal prosecution or asset forfeiture," according to the site.

"The claim by the Obama Administration that it's not undermining the laws of medical marijuana states like California is becoming less and less tenable," said Don Duncan, California Director of ASA.

"The Attorney General and the president must be held accountable for actions by their U.S. Attorneys that are harming untold numbers of patients," he continued. ASA calls itself the country's leading medical marijuana advocacy group.

Harborside's founder, Steve DeAngelo, told the Los Angeles Times that he was the subject of a justice department witch hunt.

"People are not going to stop using cannabis, they're just going to buy it in the illegal marketplace... on the streets... If Harborside is not in compliance with state law, no one is," he said.

A statement on Harborside's website said the clinic "has nothing to be ashamed of" and vowed to fight the potential eviction "with every legal means at our disposal." While the federal government has not yet seized the properties it will post a notice of the action, serve the owners with the lawsuit and record a *lis pendens* with the respective counties, according to the forfeiture actions.

The lawsuits were filed against Real Property and Improvements Located at 2106 Ringwood Avenue, San Jose, California and Real Property and Improvements Located at 1840 Embarcadero, Oakland, California.
