

The scope of work it was follows:-

- 2.1 Detail total station Survey, soil investigation of the site.
- 2.2 To Prepare conceptual, preliminary and detail drawing of the proposed Building Plan, elevation, section, earthquake resistant structural design, working drawing and detail drawing of services (Interior designing, electrical, Sanitary, water supply, sewerage, Air conditioning and fire fighting etc.) of proposed building along with proposal for water harvesting.
- 2.3 To prepare its detailed specification, bill of quantity estimate, based on present PWD BSR and rate analysis as per PWD provision and specification of all items.
- 2.4 To get proof checking of structural design and drawings by IIT's/NIT's/, MPUAT Udaipur or approved structure engineer/designer.
- 2.5 To prepare landscaping drawings.
- 2.6 To prepare a prototype model of the approved design of the ADM block.
- 2.7 To assist in supervision as and when required by RSRDC.
- 2.8 To get approval of drawings/completion certificate from local authorities and client department.
