

# PEORIA PARK DISTRICT SOCCER OFFICIAL INDEPENDENT CONTRACTOR AGREEMENT

- I. It is the intention of the Peoria Park District (hereafter, District), to create a non-exclusive Independent Contractor Relationship with either IHSA or USSF Soccer Official, (hereafter referred to as "Official") for officiating services for the Youth Travel/Recreational Soccer Leagues and/or the Adult Recreational Soccer Leagues for the 2015 season.
  - A. Official acknowledges and agrees that Official is not entitled to any benefits or protections afforded employees of the District or bound by any obligations of employees of the District. Official understands and fully agrees that Official will not be covered under provisions of the unemployment compensation insurance of the District or the workers' compensation insurance of the District, and that any injury or property damage on the job will be Official's sole responsibility and not the District's. Also, it is understood that Official is not protected as an employee or as a person acting as an agent or employee under the provisions of the general liability insurance of the District, and therefore, Official will be solely responsible for Official's own actions.
  - B. It is the intention of the parties to create a non-exclusive independent contractor relationship. Official may engage in other business activities and provide similar services to other entities and business.
  - C. Official agrees not to hold him/herself out as an employee or joint employee of the District to members of the public.
  - D. Official acknowledges and agrees that Official is solely responsible to pay all applicable federal, state and local income and withholding tax obligations or contributions imposed by social security, unemployment insurance and workers' compensation insurance on behalf of Official.
- II. Official shall at all times have sole control over the manner, means and methods of performing the services required by this agreement according to Official's own independent judgment.
  - A. The 2015 fee for each assigned game shall be \$22 (youth travel league), \$18 (2-3 rd grade youth rec), \$20 (4-8 th grade youth rec), \$30 (adult rec league), \$35 (adult rec men's league) and will be paid based on the Assignor's records.
  - B. The District will report payments to an individual of \$600 or more to the IRS on Form 1099-Misc. Official must provide to the Assignor a signed W-9 prior to receiving payment.
- III. Official agrees to comply with all applicable facility, park district, local, state and/or federal laws, rules, and regulations.
- IV. Either party may terminate this contractual agreement at anytime.
- V. This contract constitutes the entire agreement between the parties pertaining to the subject matter hereof and supersedes all prior or contemporaneous agreements and understandings either oral or written of the parties in connection therewith. No modification of this contract shall be effective unless made in writing, signed by both parties and dated after the date hereof. This contract is non-assignable by Official and shall automatically expire on December 31, 2015.
