I, John Doe, respectfully submit this written declaration to the Court pursuant to CVC 40902.

I object to any testimony, evidence, and/or declaration submitted by the officer based on hearsay and lack of foundation. The officer's declaration fails to establish an independent recollection of the facts to which the officer attempts to testify.

I deny all allegations made by the officer in support of this citation both generally and specifically. I deny that I made any statement implicating my culpability such as an allegation that I may have made a statement of apology at the scene.

I am over the age of 18 years and am otherwise competent to testify to the facts set forth below. I am the person named on the citation made the basis of this hearing. Each fact set forth below is based upon my personal observations. Otherwise the statement is made, not for the truth of the matter asserted, but to satisfy some foundational purpose.

I plead Not Guilty to the charge or charges set forth in the citation.

When I made the U-turn, I was at a location where an opening was provided. I made this turning movement as close as practicable to the extreme left-hand edge of the lanes moving in my direction of travel immediately prior to the initiation of the turning movement.

If the court does not find in my favor in this case, I request assignment to a DMV approved traffic school.

If the court does not find in my favor in this case, I request a Trial de Novo.
