

The unsuccessful applicants of Narnaul (EWS, LIG, MIG and HIG) shall deposit 10% amount 3. up to 01.05.2015 in the concerned authorized banks where they have already applied mentioning their old provisional number and application form number as well as mobile number.

In case of Bawal all the Successful and Unsuccessful applicants may inform their category of reservation up to 01.05.2015 in the concerned banks where they have already applied mentioning their old provisional number and application form number as well as mobile number.
