# Request for Expression of Interest Integration of Wind & Establishment of Wind Integration Grid Code

The Government of the Arab Republic of Egypt has received a grant from the African Development Bank (AfDB) toward the cost of studying the integration of wind power in the Egyptian power system and the establishment of a wind integration grid code for Egypt.

The Egyptian Electricity Transmission Company (EETC) now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services, including:

- History of past and current consultant's activities;
- Experience in consultancy services related to the development of protection, control and operational guidelines, power system planning and studies, wind modelling, preparation of Wind Grid Codes and specifying system requirements to accommodate high wind penetration levels;
- Any information deemed by the consultant to be relevant to this project.

Consultants may also constitute joint-ventures to enhance their chances of qualification.
