INFORMATION FOR AUTHORS

Acta Cardiologica Sinica publishes peer-reviewed articles on all aspects of cardiovascular disease and basic science, including original clinical or experimental studies, review articles, case reports, short reports and letters to the Editor. As the official journal of the Taiwan Society of Cardiology, Acta Cardiologica Sinica also publishes abstracts of reports to be presented at the Annual Scientific Sessions of the Society.

Submission of Manuscripts

Articles are accepted for consideration only if they are submitted solely to this journal. Each article is submitted with the understanding that all authors have reviewed and approved the data in the final manuscript. All sources of support for the research submitted in a manuscript, from both profit and nonprofit organizations, should be cited. Except for review articles, the editors will not publish articles in which a significant portion of the data has been published or submitted for publication elsewhere. The Taiwan Society of Cardiology reserves copyright and renewal on all published material, and no part of such material may be reproduced elsewhere without permission from the Society.

Manuscript Guidelines

Manuscripts must be submitted in triplicate and should conform to the Uniform Requirements for Manuscripts Submitted to Biomedical Journals (*N Engl J Med* 1997;336:309–15). The manuscript text should be double-spaced throughout. The Title page, Abstract, Body Text, Acknowledgments, References, Legends, Tables and Figures should appear in that order on separate sheets of paper. Define all abbreviations at first appearance, and avoid their use in the title and abstract. Use generic names of drugs. Once a manuscript has been accepted, it should be submitted on a virus-free 3.5-inch computer disc or a compact disc as a text file or Microsoft Word file.

Title Page

The title page should include a brief and specific Title, full names and affiliations of each author, and an address, telephone number, facsimile number and E-mail address of the corresponding author. Acknowledgment of grant support should be cited. A short Running Title (40 characters or less) should be provided. Where applicable, a Chinese title and Chinese authors' names should appear in Chinese characters below the English title.

Abstract

A concise description (not more than 250 words) of the Purpose or Background, Methods, Results and Conclusions is required. Up to 3–6 Key Words or phases for subject indexing should be provided below the abstract. Where applicable, a Chinese translation of the abstract should be also included.

Body Text

The text of Original Articles should be divided into Introduction, Materials and Methods, Results and Discussion sections. Other article types may use other formats as described below. Acknowledgments are typed at the end of the text before references.

References

References are cited numerically in the text and in superscript. References should be numbered consecutively in the order in which they are mentioned in the text. References should quote the last name(s) followed by the first initial(s) of the author(s). When a referred paper has four authors or less, provide the names of all authors. For papers with more than four authors, list the first three authors' names followed by "et al.". List specific page numbers for all book references. Refer to Index Medicus for journal titles and abbreviations. Examples are provided below. Authors are responsible for the accuracy of the citation information that they submit.

Tables and Illustrations

All tables should be cited, by number, in the text. Each table should have a brief informative title. Define all abbreviations used and provide any other relevant information (e.g., statistical significance) as a footnote. Place each table on a separate page.

Two sets of illustrations must be submitted and enclosed in a separate envelope. Label the back of each figure with the title of the article and an arrow indicating the top of the figure. Figure legends should appear on a separate sheet of paper and should be brief, providing sufficient description for figure interpretation. Number figures in the order in which they are mentioned in the text. Photographs and drawings should be unmounted, glossy prints, 5"×7" in size. Internal scale markers on photographs are desirable.

An author who chooses to include in their submission to *Acta Cardiologica Sinica* any tables, illustrations or other images that have been previously published elsewhere is responsible for obtaining permission to reproduce the image(s) from the copyright holder. A copy of the letter of permission to reproduce should be included with the manuscript at the time of submission.

Article Categories

Review. Invited articles by recognized authorities on various topics, to include reviews of contemporary clinical pathways. The format for such articles will be up to the contributing author and the editorial board. Authors should quote articles for review to the *Acta Cardiologica Sinica* Editorial Office.

Original. Studies on human subjects or laboratory animals and in vitro experiments will appear in this category. In general, these manuscripts should not exceed 6,000 words in total length, including references and figure legends.

Brief Reports. Brief reports contain short, concise clinical or technical notes, or preliminary experimental results. They should contain laboratory or clinical findings, representing important new insights or major advances, produced with established methods or new applications of an established or new method. They should not exceed 3,000 words in total or have more than three figures. The abstract should not exceed 200 words. The editors reserve the right to decide what constitutes a *Brief Report*.

Case Reports. Case reports should have no more than six authors and should not exceed 2,000 words in total or have more than two figures. The Materials and Methods and Results sections should be replaced with a Case Report(s) section. This should include a statement of the problem, patient history, diagnosis, treatment, results, and any other information pertinent to the case(s). All other sections should follow the format for original articles. The abstract should be no longer than 150 words and should include statements of the problem, clinical manifestations, methods of treatment, and outcome. The number of references should not exceed 15.

Letters to the Editor. The editors welcome all opinions and suggestions regarding the journal or articles appearing in the journals. An author who submits a Letter should provide a cover letter, on his/her own stationery, to the Editor-in-Chief stating why the Letter should be published. The Letter in triplicate (as well as references) should be typed, double-spaced, on a separate sheet of plain white paper and limited, with few exceptions, to four pages. A title for the letter should be provided at the top of the page. The writer's full name should be provided. A letter concerning a particular article in Acta Cardiologica Sinica must be received (from authors within Taiwan, R.O.C.) within 6 months of that article's publication. The Letter should be no more than 250 words long and may include one table or figure and up to four references. The editorial board reserves the right to edit any letter received.

Editorial Commentary. These will include invited articles or brief editorial comments representing opinions of local and foreign experts in cardiovascular medicine and research. They should be 1000-1500 words in length and not more than 20 references should be cited.

Author Reprints and Costs

Fifty reprints of each article will be furnished to authors free of charge. Additional reprints will be charged at a rate of US\$20 per 50 copies. No charges will be instituted for articles less than seven printed pages. The cost of color reproductions will be borne by the author.
