DRESS CODE - WEDDINGS

- 1) Appropriate attire is required of all persons who attend a wedding held in the Marysville Municipal Court courtroom. Suggested dress attire for the wedding couple and their guests are:

Male - Long or short-sleeved shirt with collar, slacks or dress type denim pants, and appropriate footwear.

Female - Dress, skirt or slacks with blouses, and appropriate footwear.

- 2) The following items are ***considered inappropriate and are not to be worn*** for weddings held in the courtroom.

- A. Shorts
- B. Cut-off jeans or slacks
- C. Tank tops, halter-tops, muscle shirts or sleeveless t-shirts
- D. Jeans or pants with obvious tears or holes
- E. Torn or ragged t-shirts
- F. Dirty or muddy clothing
- G. Exposed undergarments or under clothing of any kind
- H. Exposed midriffs
- I. Thong-type footwear and flip-flops or bare feet
- J. Any type of clothing with abusive or objectionable wording or emblem on them
- K. Hats

- 3) Judge Grigsby may postpone the ceremony if dress is not appropriate.
