Name, Roll Number, signature, which do not have fully and correctly coded, will not be evaluated and "Zero" marks will be awarded to them. No correspondence in this regard will be entertained by the BSF.
- f) Fee once paid will not be refunded under any circumstances.
- g) The BSF authority will be using software to detect attempted irregularities in an examination Hall. The Candidates are advised to desist from use of any unfair method in the examination hall which will render them ineligible for further consideration for the examination and also lead to their debarment from BSF examinations in future.
- h) Candidates are not permitted to use Mobile Phone, Calculators or any other electronic/electrical device. Candidates must not, therefore, bring Mobile Phone, Calculators or any other electronic / electrical device inside the Examination premises. Possession of these items, whether in use or not, will be considered as "use of unfair means" in the Examination and appropriate action will be taken by the BSF authority against such candidates, as per existing policy of the BSF.
- i) Those candidates who are declared unfit in Physical Standards, i.e., height and chest, may prefer an appeal, if he/they so desire, to the appellate authority present on the PET ground. The decision of the appellate authority will be final and no further appeal or representation in this regard will be entertained.
- j) Those candidates who qualify in written test will appear in second phase. Second phase examination will be conducted in five stages of which details are given below:-
- i) **First stage** :- Documentation in respect of written test qualified Candidates will carry out.
- ii) Second stage :- Physical Standard Test (measuring of Height, Chest & Weight will carry out only those candidates whose documents found satisfactory.
- iii) **Third stage** :- Physical Efficiency test (candidates qualified in PST will only appear in PET. Events of PET are as under:-
 - (i) 1.6 Km race in 6.5 minutes
 - (ii) Long Jump -3.65 Mtrs in three chance
 - (iii) High Jump 1.2 Mtrs in three chance

(Ex-service men are exempted from physical efficiency test).

- iv) Fourth stage :- (aa) interview will be carried out only those candidates who qualify in the PET.
 - (ab) Dictation test (in English) for HC(RO) only 10 Marks
- v) Fifth stage :- Final medical :- Candidates of ASI(RM) and HC(RO) posts who qualified in fourth Stage will only be allowed for final medical.
- k) The candidates shall make their own arrangements for boarding and lodging during period of test/medical examination, which may take 4-5 days or more.
- 1) No T.A./D.A. will be admissible for the above purpose.
- m) Final selection will be on merit basis.
