Pre –Qualification Requirements:

Terms & Conditions

- 1. The quoted price shall be 'FIRM' and final for entire contract period.
- 2. The contractor shall fully responsible for acts of the persons engaged; any misconduct by the persons engaged by the contractor shall be treated as breach of contract for which RVUN has full liberty to take an action including legal action against the contractor.
- 3. The contractor shall be responsible for all rules/regulations regarding Labour Act and CPF Act etc. Any liability arising out of such rules/regulations shall be to the contractor's account and only the contractor shall be responsible for the same.
- 4. The contract shall be for one year period which can be further extended for a period of one year and, frequency/supply of man-power can be extended upto requirement.
- 5. The contract can be terminated at any stage on unsatisfactory performance.
- 6.

The normal working hours are 09:30 AM to 06:00 PM on all working days (up to 26 working days in month).

- The contractor shall submit the monthly bills in triplicate along with verification of attendance from offices
 & verification of photocopies on every 1st of next month to the concerned Officer In charge.
- 8. The offers shall be valid for a period of 90 days from the date of opening.
- 9. The contractor shall himself be fully responsible for any mishap/accident of engaged person(s) during providing the services. The contractor shall bear the compensation for accident, if any.

- 10. The EMD of successful bidder shall be converted into Security Deposit, in case contract period/value exceeds, SD shall be increased proportionately, which shall be refunded after completion of contract. The EMD of unsuccessful bidder shall be refunded after finalization of the tender.
- 11. The contractor shall be primarily responsible for all statutory deductions & contribution on account of CPF/EPF as per rules/act in force and subsequent amendment during contract period. The proof of CPF so deposited by contractor for individual workers engaged for this work shall have to submit with monthly bills. If contractor fails to comply, a recovery @16% from gross value of bills shall be made.
- 12. 100% payment shall be made by CAO (TD), RVUN, Jaipur on satisfactory services provided by the contractor and certified by the Officer In charge.
- 13. For non-providing any service a deduction of Rs.200 per day per person shall be made from monthly bills of the contractor. The deduction can be made from any available financial hold. Such shortcomings shall be informed to officer incharge in writing.
- 14. Contract Agreement on non-judicial stamp of Rs. 500 as per norms in a prescribed format shall be executed by the contractor.

The indenture made at Jaipur this _____ days of month ______ of the year ______ and between the CMD, RRVUNL hereinafter referred to as the Owner, which expression unless the contract does not permit, includes successors and assigns of the one part and M/s _______ herein referred to Contractor for works of "Services for photocopying, electrician for electricity works, dak distribution, assistance in record keeping & pantry services at Vidyut Viniyamak Bhawan and at Vidyut Bhawan, Jaipur." for Rajasthan Rajya Vidyut Utpadan Nigam Ltd. Which expression unless the context does not permit includes their successors, heirs, executors and permitted assigns of the second part, witness as follows:

- 1. The Contractor do by these presents agree execute the works of "Services for photocopying, electrician for electricity works, dak distribution, assistance in record keeping & pantry services at Vidyut Viniyamak Bhawan and at Vidyut Bhawan, Jaipur." for execute from the Contractor specified work order the work in the No. appended with the terms and conditions in the said order. The General Terms & Conditions of the Contract appended hereto are considered a part of this agreement.
- 2. The Contractor is also bound to fulfill all conditions mentioned in the relevant clause GCC.
- 3. The sevices to be providing under this agreement shall be as per terms and conditions of the above order and as per the **TNM** No.601 for ""Services for photocopying, electrician for electricity works, dak distribution, assistance in record keeping & pantry services at Vidyut Viniyamak Bhawan and at Vidyut Bhawan, Jaipur." as set forth in the schedule referred to above.
- 4. In case of dispute as to whether any done are or are not in accordance with the specifications set forth in the schedule, the decision of the Superintending Engineer (TD-II), RRVUNL, Jaipur shall be final and binding on both the parties .
- 5. If the Contractor fails wholly or in part to fulfill this agreement, the owner shall be entitled at his discretion retain the whole or any part of the deposit made by the Contractor and if the loss suffered by the Owner exceeds the amount of said deposit, he will be entitled to recover the loss from the Contractor, in the manner as may be expedient.
- 6. If any some remains due, or become recoverable from the Contractor on account to the non fulfillment of this agreement or on account to of any

other reason, the Contractor shall pay the same immediately on demand. If the Contractor do not make such payment on demand the owner shall be entitled to recover the same from the Contractor as arrears of land revenue.
