**BY PARTICIPATING IN THIS CONTEST, ALL
ENTRANTS AGREE TO BE BOUND BY
THESE OFFICIAL CONTEST RULES (“THE
RULES”)**

THE RAFFLE:___The Raffle will run from October 8th, 2014 at 9:00 a.m. Eastern Time (“ET”) to Saturday November 8th to 11:00 p.m. ET (the “Raffle Period”).

SPONSOR:___The sponsor of this Raffle is Three to Be (Charitable BN: 805824513 RR0001) (“Sponsor”).

ELIGIBILITY:

To be eligible for entry and to be eligible to win the either Prize 1, Prize 2 or Prize 3 (defined below), you must be a resident of Canada (excluding the province of Quebec) and have reached the legal age of majority in Ontario (age 18) at the time of entry.

TO ENTER:

You may enter the contest via ticket entry by one or more of the following means:

□ **Online.** Visit www.threetobe.org/raffle, select the number of tickets you wish to obtain and provide the requested contact and payment information to complete the ticket purchase.

□ **Raffle order form.** Complete and return the raffle ticket pre-order form provided along with tickets for the Three to Be Stems of Hope Gala, THRiVE (the “Gala”), select the number of tickets you wish to obtain and mail the form to Three to Be, 452 Wilson Ave. Toronto, ON M3H1T6. Form must be received by Friday November 7th at 12:00pm.

□ **Gala.** Obtain a raffle ticket at the Gala, which will take place at Kool Haus in Toronto, Ontario, on November 8th beginning at 6:30p.m. ET. Tickets may be obtained at the raffle booth and from raffle volunteers at the Gala. You must select the number of tickets you wish to obtain and provide requested contact and payment information to complete a ticket purchase. Each ticket represents 1 ballot entry into the Raffle. Tickets are available in multiples of 1, 3 or 10 as follows: 1 ticket at a cost of \$50.00; 3 tickets at a cost of \$100.00; or 10 tickets at a cost of

\$250.00. Tickets will be issued directly to entrants who purchase tickets at the Gala. Entrants who obtain tickets via online or raffle order form methods of entry will not be issued physical tickets – their ballots will automatically be entered into the Raffle.

However, online or raffle order form entrants who attend the Gala, may (at their option) pick up their assigned tickets at the Raffle booth on-site at the Gala. **NO PURCHASE NECESSARY.** If you are otherwise eligible for the Challenge, you may send a request and essay to obtain an entry into the Raffle by completing all of the following steps: print your first name, last name, telephone number, complete mailing address (including postal code), age and signature on a plain white piece of paper and mail it (in an envelope with sufficient postage) along with a 50 word or more unique and original essay on the subject of the impact of Three to Be's fundraising on the lives of children with neurological disorders in Canada. ET (noon) on November 7th, 2013. Upon receipt and verification of essay- entry request in accordance with these Rules, you will receive

one (1) Entry in the Contest per unique and original Essay per envelope with sufficient postage. The Releases (defined below) take no responsibility for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed mail-in essay entries.

All entries become the property of the Sponsor, and none will be returned. The Sponsor assumes no responsibility for lost, delayed, destroyed, illegible, or misdirected entries. The Sponsor will contact only the persons whose names are drawn in accordance with the procedure outlined below.

THE DRAW:

At approximately 11:30 p.m. on November 8th, 2014 (the “Draw Date”), 2 entrants shall be selected, by a random draw from among all eligible entries received during the Raffle Period. The selected entrant whose name is drawn first will be eligible to win Prize 2. The selected entrant whose name is drawn second will be eligible to win Prize 1. The ballot of a selected entrant will not be returned to the pool of eligible entries.

The odds of winning the Prize will depend on the total number of eligible entries received at the time of each draw.

TO WIN:

The Sponsor or its designated representative(s) will make a minimum of two (2) attempts to contact each selected entrant by telephone (using the information provided on the entry ballot) within 2 business days of the Draw Date, and will leave one voice message (if voice message option is available). If a selected entrant cannot be contacted within 2 business days of the Draw Date; then he/she may be disqualified (and will forfeit all rights to the relevant Prize) and the Sponsor reserves the right, in its sole and absolute discretion, to randomly select an alternate eligible entrant from among the remaining eligible entries as a potential winner for the applicable Prize (in which case the foregoing provisions of this section shall apply to such new selected entrant).

BEFORE BEING DECLARED A CONFIRMED PRIZE WINNER, each selected entrant will be required to: (a) correctly answer a mathematical skill-testing question without mechanical or other aid; and (b) within 5 business days of notification, return signed declaration and release forms provided by the Sponsor in respect of the selected entrant which

PRIZE CLAIM DEADLINE:

Prizes must be claimed by November 29, 2014. Any Prize not claimed by this date may not be awarded or may be conferred on any other person as the Sponsor deems appropriate, at the sole discretion of the Sponsor.

GENERAL TERMS AND CONDITIONS:

Sponsor is not responsible if for any reason any event or element at the Gala is changed, delayed or cancelled in whole or in part. Winner (and winner's guest, if applicable) must comply with any terms and conditions established by the organizers of the Gala for attendance or participation in the Gala and any

terms and conditions set forth in these Rules or otherwise by the Sponsor.

The “Releasees” are not responsible: i) for any human or other error in the administration of the Raffle; ii) for the unavailability or loss of ballot boxes or individual ballots, illegible or incomplete ballots, erroneous potential winner or winner announcements; or iii) if an event or an experience associated with all or part of the Prizes is delayed, rescheduled, cancelled or otherwise unavailable for any reason. Raffle entrants forever release and discharge the Released Parties from any and all actions, causes of action, claims, costs and payments for damages, loss, injury, or death, however occurring, relating to the Raffle or the Prizes.

Sponsor reserves the right to terminate or suspend the Raffle in whole or in part, and at Sponsor’s discretion, award none, some or all of the Prize in a random draw from all entries received up until the date and/or time that the Raffle is terminated, as Sponsor determines in its sole discretion, for any reason, including, but not limited to, if events beyond its reasonable control make continuation not feasible, or if the integrity of the Raffle is impaired for any reason including, but not limited to, the loss or

destruction of ballots and/or ballot boxes, if a virus, bug, computer, electronic or system malfunction, or if human error, or if another cause beyond Sponsor's control, should corrupt the administration, security or fair play of the Raffle. Sponsor also reserves the right to amend these Rules at any time and without notice to

entrants for any reason, including, but not limited to, correcting clerical errors in these Rules or promotional materials. All of Sponsor's decisions concerning the Raffle are final and binding on all entrants.

Raffle entries are subject to verification by Sponsor. Any entry that is, in Sponsor's opinion, fraudulent, incomplete, mutilated or that does not allow Sponsor to correctly identify the entrant will be rejected and will not entitle the individual to an entry or the Prizes. Any person who enters or tries to enter the Raffle in a manner which is, in the opinion of the Sponsor acting in its sole and absolute discretion, unfair to the other entrants will be automatically disqualified and may be referred to the appropriate authorities.
