

2015 Conference Pre-Institute

NCCASA is pleased to expand our conference by hosting the 2015 Pre-Institute. This time is a conscious effort to address the four emerging issues impacting local service providers and the national anti-sexual violence movement. Join us for a day focused specifically on responses Campus Sexual Assault, Human Trafficking, the Prison Rape Elimination Act (PREA) and Military Sexual Assault.

The Pre-Conference Institute will begin on Tuesday, May 19, 2015 from 9:30am-3:30pm, with registration beginning at 9:00am.



The NCCASA Campus Pre-Conference Institute is intended to give participants of the 2015 NCCASA Biennial Conference a "500 ft. view" of some of the issues rising to the surface on the national level that impact NC campuses. Our speakers for the day are all nationally recognized experts who work/have worked with national, state, and local entities to provide training, technical assistance, and services related to campus sexual violence. The Campus Pre-Conference Institute is appropriate for anyone working on a campus or with campuses to prevent and respond to sexual violence.



This Institute will provide an overview of the policies set forth by the Department of Defense regarding the prevention of and response to sexual assault in the military. The focus of the Institute will be highlighting the programs implemented by the military aboard Marine Corps bases in North Carolina. Additional topics to be covered include but not limited to Sexual Assault Response Teams (SARTs), community partnerships and an overview of military culture.



Human Trafficking is a hidden crime & the victims face many barriers to obtaining assistance. (Polaris Project, 2010). Therefore responding effectively through community collaboration help to ensure victims receive adequate & appropriate services and is crucial to survivor restoration. The Human Trafficking Pre-Conference Institute will highlight national, state & local partnerships that focus on restorative justice initiatives for trafficked persons.



The Prison Rape Elimination Act (PREA) of 2003 was enacted by Congress to address the problem of sexual abuse of persons in the custody of U.S. correctional agencies. Its purpose is to analyze the prevalence & effects of sexual assault in incarcerated facilities and to provide these facilities with resources for the detection, prevention, reduction & punishment of sexual assault & rape. The Institute will bring together corrections & rape crisis center practitioners in formal discussions regarding the Act. Participants will be able to ask questions on PREA relevant standards, network with peers, and discuss implementation strategies.

KEYNOTE SPEAKERS



Mychal Denzel Smith

is a Knobler Fellow at The Nation Institute and a contributing writer for The Nation Magazine, where he writes about issues of politics, race, gender, and black male identity. His work is widely known and respected as one of the leading voices on racial justice, appearing in publications like The New York Times, The Atlantic, and The Guardian. He was named by Ebony Magazine's as "What's Next" in politics and civil rights for 2014, was included as one of Planned Parenthhood's 99 Dreamkeepers for Black History Month in 2015, made the list of New Social Justice Leaders by Sean Combs' Revolt TV, and was also recognized among The Root 100. Mychal is also a TV commentator and public speaker, appearing on Al Jazeera America, CNN, HuffPost Live, and MSNBC.



Jeff Dion

has championed crime victims' rights for more than two decades. Jeff lobbied the Virginia General Assembly, resulting in 13 victims' rights bills being enacted into law. These statutes established a victim's right to be present in the courtroom, the right to offer oral impact testimony at sentencing, the right to confer with the prosecutor, a civil cause of action for stalking, an expanded civil statute of limitations for victims, and an expanded legal definition of "victim."

In 1998, Jeff joined the staff of the National Center for Victims of Crime, where he currently serves as the Director of the National Crime Victim Bar Association. In that capacity, he lectures throughout the country to foster greater communication and understanding among crime victims and trial attorneys. He trains victim advocates in the application of civil litigation and instructs fellow attorneys in crime victim issues and services.
