What is CASA?

When a child enters the foster care system because his or her home is no longer safe, a judge may appoint a committed, trained volunteer called a Court Appointed Special Advocate®, or CASA, to help the child. The volunteer's focus is on that child, giving hope and help in guiding the child to a safe, permanent, and loving home.

CASA volunteers are carefully screened and go through extensive training before being appointed by judges to advocate for one child or a set of siblings. CASA volunteers research case records and gather information from everyone in the child's life, including family members, teachers, doctors, lawyers, social workers and others. Their independent assessments and advocacy help judges make better decisions in foster care cases.

Today, CASA is a national network of more than 933 CASA organizations that are recruiting, training and supporting CASA volunteers in 49 states and the District of Columbia.

Texas CASA

Texas CASA is the statewide membership association of 71 local CASA programs in Texas. Texas CASA partners with these local programs to provide a voice for abused or neglected children through volunteer advocacy and change in the foster care system.

Since 1989, Texas CASA has worked to bring more CASA volunteers and services to abused or neglected children in foster care. Our vision is to provide a CASA volunteer for every child who needs one.

Child Advocates San Antonio

The mission of Child Advocates San Antonio is to recruit, train, and supervise court-appointed volunteer Advocates who provide constancy for abused and neglected children and youth while advocating for services and placement in safe and permanent homes.

Since its establishment in 1984, Child Advocates San Antonio has grown to include almost 500 volunteers serving approximately 1,600 children and youth annually. Recognizing that every child has a fundamental right to have someone whose full attention is focused on his or her needs, the organization has committed to a simple but powerful vision: helping to change the lives of every abused and neglected child entering State protective care by 2020.
