- 7. Any interlineations, erasures or overwriting shall be valid only if they are signed or initiated by you or any of your duly authorized representative/s.
- 8. PAGCOR shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications one (1) day prior to the actual rental of the equipment.
- 9. The supplier agrees to pay a penalty of one-tenth of one percent (1/10 of 1%) of the unperformed portion for each day of delay, including non-working days (i.e. Saturday and Sunday), legal holidays or special non-working holidays. PAGCOR shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
- 10. Bidders shall provide One (1) Video Conferencing Engineer per site.
- 11. PAGCOR shall shoulder the accommodation and transportation of all the Engineers to be deployed in all PAGCOR sites.

12. Other terms and conditions are stated in the Annex A of the Purchase Order Form.
